Since I wrote my first major thesis on the Kennedy assassination in 2011, a great deal has happened in Kennedy research. Several new amateur films have surfaced, and several witnesses to the fatal events of 1963 have come forward with their first-hand accounts. The most remarkable of these witnesses are the woman who was Lee Harvey Oswald's girlfriend and lover in the last months of his life, Judyth Vary Baker, and lower-level Mafia member Roderick MacKenzie III.

Vary Baker worked with Lee Harvey Oswald on a CIA-led project in New Orleans in the spring of 1963. The aim of the project was to develop highly potent cancer cells that could be used as a biological weapon to kill Cuba's dictator, Fidel Castro. For various reasons, the plan was not realised, even though it did succeed in developing cancer cells that were very fast-growing and had a high mortality rate. The cells were trialled by injecting inmates in prisons, and the first prisoners began to die after only about a month. It must be said that Judyth Vary Baker withdrew from the project when she realised that the cancer cells were to be tested on innocent people, while Oswald completed his part of the project and travelled to Mexico to hand them over to a contact person, who did not show up.

Oswald was then ordered by the CIA to travel to Dallas and found work at The Texas School Book Depository. Oswald was told that his mission in Dallas was to act as a CIA informant, and he eventually made contacts within the circles that planned to kill the president on his visit to Dallas later that autumn. He was also part of an abortion team that aimed to prevent the assassination from taking place. But Oswald was fooled and was in fact manoeuvred into the role of patsy. He was wanted shortly after the murder and quickly arrested by the police. According to Vary Baker, Oswald knew full well that his life was in danger but chose to carry out his mission 'to the bitter end'. And we all know how it ended - in the most tragic way - both Kennedy and Oswald were murdered.

What Roderick MacKenzie III tells us is at least as remarkable as Judyth Vary Baker's story. MacKenzie did odd jobs for the mafia and specialised in forging ID cards. Like Oswald, he was ordered to Dallas and tasked with setting up a so-called 'safe house', which the Mafia would

use as a hideout during one operation or another. At the time, MacKenzie did not know that the president was expected to visit Dallas, but he set up the safe house as requested. He was able to observe everyone coming and going, and eventually he realised what was going on: 'The big event' or "the hit parade" as the plans to assassinate the US President were called.

On the day of the assassination, MacKenzie was asked to meet a couple of key mafia members at a café - presumably to help provide them with an alibi. During the café visit, one of the mafia members kept leaving the table to talk on the phone, and when he returned the last time, he was clearly agitated, according to MacKenzie.

But the most remarkable part of MacKenzie's story is when he later met the man known as Lyndon B. Johnson's 'hitman', who had removed several 'undesirables' on Johnson's orders - Malcolm 'Mac' Wallace. Obviously intoxicated and drinking heavily while the two were together, Wallace began bragging about his involvement in the assassination - and not only that, he revealed that Dealey Plaza was surrounded by several firing squads in many different positions, so that Kennedy was effectively under crossfire - from behind, from both sides and from the front.

According to Mac Wallace, he himself fired from the sixth floor of the textbook warehouse, and Lee Harvey Oswald was also offered to fire shots from there. But as we know, it was not Oswald's intention to shoot, but rather to try to prevent the assassination.

The last thing I want to point out here in the introduction is that two amateur films sweeping past the entrance to the schoolbook depository quite clearly show a man standing in the shadows, in one corner, drinking a Coke. The man is known in the research community as 'the prayer man' because he holds his hands in front of him much like when you pray. In one of the films, taken by David Wiegman, you can even see that he raises his hand to his face, as if he is drinking. 'The prayer man' is most clearly seen in the other film, taken by Jimmy Darnell. And personally, I have no doubt that it's Lee Harvey Oswald standing there in the entrance hall.

It's completely consistent with his first statement during the interrogations, where he claimed that he went to have lunch at 12.00. He first went to buy a Coke from the vending machine on the second floor, and then down to the lunchroom on the first floor. A little later, he went down to the exit with many of the other employees to watch the car parade with the president. And the films showing the prayer man prove that Lee Harvey Oswald was telling the truth.

But the incredibly tragic thing happened, that the man who was willing to try to save the President's life at the risk of his own.

Most of the articles collected here have previously been published in Vårt Land's former debate forum, Verdidebatt. I have revised them with this collection and made some minor changes.

Startling new information about Lee Harvey Oswald's role in the assassination of JFK.

Before the assassination of John F. Kennedy, the alleged murderer, Lee Harvey Oswald, lived for several months in New Orleans. Another person staying there was the highly talented cancer researcher Judyth Vary Baker, and the two eventually got to know each other and developed a romantic relationship. They were both involved in the CIA's plans to assassinate Cuba's leader, Fidel Castro, using highly potent cancer cells developed by the CIA.

After JFK's assassination, Lee Harvey Oswald's mistress was told in no uncertain terms that if she ever told anyone about her knowledge, her life would come to an abrupt end. These days, however, she is coming forward with shocking new information that should shake the US and the world.

This article is based on several interviews with the woman who was Oswald's mistress in the last months of his life. Her name is Judyth Vary Baker, and she has also published a book about her relationship with Oswald: **Me & Lee - How I came to know, love and lose Lee Harvey Oswald.**

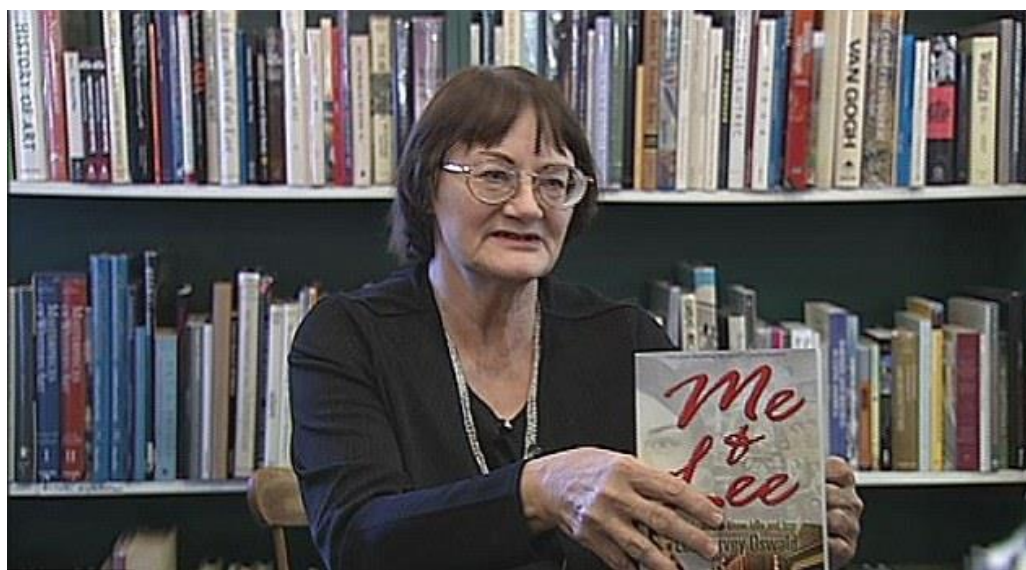


Early on, young Judyth Vary Baker revealed herself to be a gifted researcher who dreamed of developing an effective cure for cancer. Thanks to her talent, she was offered a role in the CIA's cancer project to develop highly potent and deadly cancer cells that would be used to assassinate Cuba's dictator, Fidel Castro. Judyth Vary Baker was a young and idealistic student who early on made a name for herself as a unique scientific talent. She was passionate about finding a cure for cancer and wanted

to dedicate her life to medical research. Through her research, she discovered that cancer is caused by a virus, and she had great faith that an antidote would be found. She came into the media spotlight at the age of 18 or 19, and her talent was so remarkable that she was noticed far up in the most powerful circles of American politics, who saw in her exactly the person they were looking for as a participant in a high-level scientific project.

Judyth was also a staunch opponent of Fidel Castro, and made no secret of his antipathy towards this revolutionary leader who had usurped power in Cuba. Powerful forces in the USA wanted to get rid of Castro, both within political circles, the CIA, the mafia and the Cuban exile community. One of the attempts to remove him from power is known as the failed Bay of Pigs invasion.

The plan to assassinate Castro using cancer cells.

Efforts were made on many levels to find methods to assassinate Castro. One of the methods was to use biological “weapons” to inflict deadly diseases on him. And the disease they saw the greatest potential in was cancer. And they managed to steer the young genius Judyth Vary Parker into this research project. She saw it as a noble act to participate in a project to secure American interests in Cuba, and as a young idealist she saw nothing immoral in participating. In the beginning. Judith's task was to experiment with mice that were infected with cancer cells and developed tumors as large as themselves.

But as these cancer cells were not potent enough to ensure the development of lethal cancer in a relatively short period of time, they wanted to cultivate the cancer cells that developed the fastest, and with the most lethal effect. Judyth cut off the cancerous tumors on the mice, selected cells from the most potent and fast-growing ones, and developed a type of cancer that was far more deadly and fast-growing than the starting point. These cancer cells were further processed using radioactive radiation, and mutated in many directions, into several deadly cancers.

Lee Harvey Oswald's many roles.

Judyth's laboratory was located in New Orleans, and she met one of the other employees a few days before her work began. While waiting in line at the post office, she met a young man who immediately made a lasting impression on her: Lee Harvey Oswald. Lee initiated her into his own endeavor, and allowed her to meet several of his contacts, which included the highest CIA officer in New Orleans, as well as David Ferry, Clay Shaw and, not least, a man Judyth only came to know as Rubenstein, but who she later realized was none other than Jack Ruby, the man who later murdered Lee Harvey Oswald.

Ruby was obviously a close acquaintance of Lee, and had known him since he was just a young boy. Ruby had close mafia contacts, and it is well known today that, at the time, there was a lot of collusion between the CIA, the mafia, top military and political figures and the Cuban exile community. Everyone had a common interest in removing Castro. Oswald was obviously deeply involved in several of these circles and was able to cooperate with all of them. By appearing pro-Cuba to the outside world, as secretary of the Fair Play for Cuba Committee, he also gained access to anti-American circles and was able to provide the authorities with information about pro-Castro individuals in New Orleans who could pose a threat to the USA. What was typical of Oswald, then, was that he was like a chameleon, who had several hidden agendas, but who ultimately worked actively for American interests and was loyal to American society.

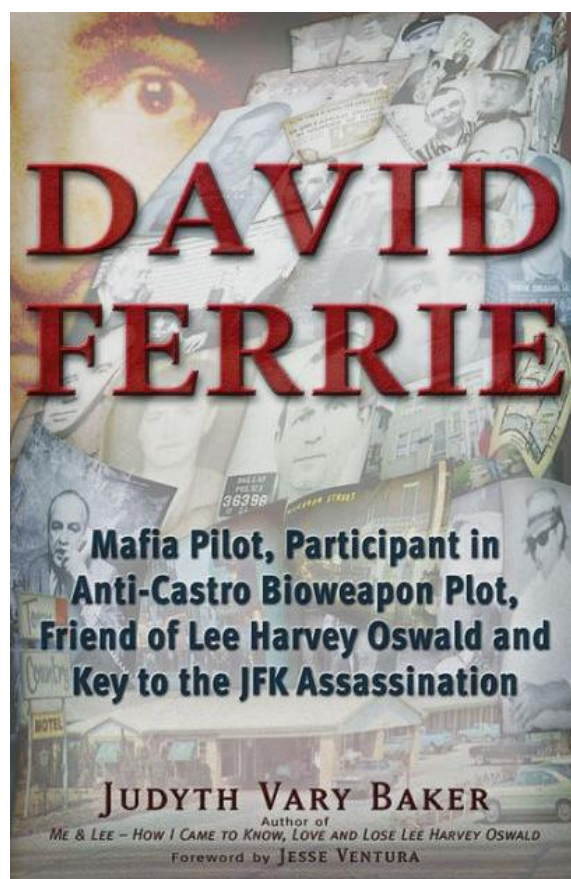
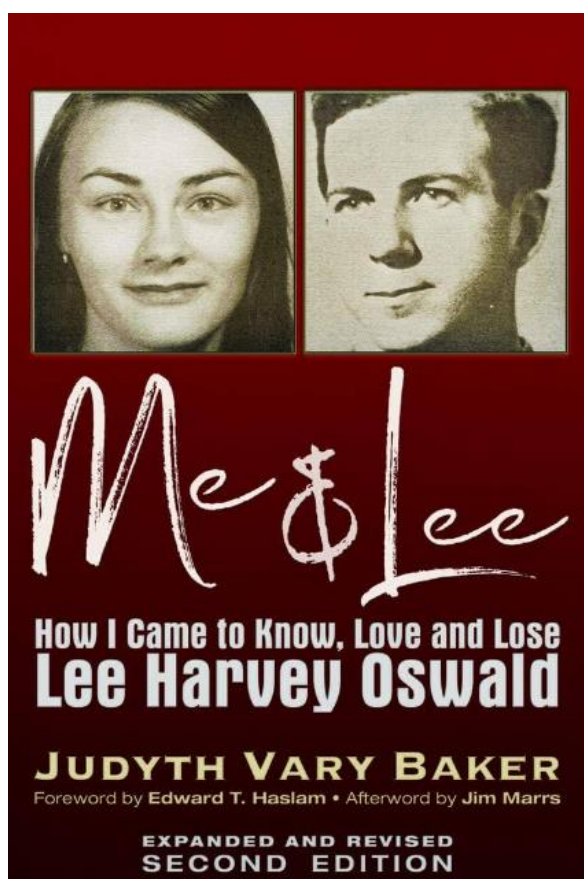
Judyth Vary Baker gets cold feet.

The management was not entirely satisfied with the results of the efforts to develop a more dangerous and deadly cancer virus, and Judyth came up with the idea of making the virus more deadly by weakening the victim's immune system by having them undergo a series of X-ray examinations, because it was well known that X-rays weakened the immune system. And when it was believed that they had gone as far as they could in creating a lethal weapon, the time came to test the virus on living organisms.

To her horror, Judith learned that inmates from prisons in New Orleans would be used as guinea pigs for the trial, but she refused and wrote a protest to her boss, who was furious. He was furious, both because she had been told that there should be nothing in writing that could reveal the experiments, but also because she objected to the project's methods. He made it clear that both she and Lee Harvey Oswald were nothing compared to the importance of the project. By this time, Judith and Lee had developed a very close relationship.

They lived only a few blocks apart and took the same bus to work every day. As they were both married, they tried hard not to consummate their relationship, but were unable to resist in the long run and became lovers. Judyth's role was dramatically altered by her remorse, but both Lee and Jack Ruby took part in injecting cancer cells into some of the employees.

Judyth's expertise was needed only once more, and that was to examine the infected after a certain period of time, to check whether they had managed to develop a cancer virus that was sufficiently fast-acting and deadly, and the first of the guinea pigs died after just one month.

Lee Harvey Oswald travels to Mexico with the infectious agent.

In the summer of 1963, Lee Harvey Oswald traveled to Mexico with a few bottles of cancer infection, which he was to give to his contacts, who were to take it to Cuba and hand it over to one of Castro's trusted medics, who was in fact US-friendly. Through their participation in the effort to kill Castro, Lee and Judyth had come to realize that many of those who wanted Castro dead also had a strong desire to kill US President John F. Kennedy. Many of them believed that he had failed his country by being too weak against Castro, and through his contacts in Mexico, Lee received confirmation that plans were being made to assassinate JFK. He didn't like this very much, as he had nothing whatsoever against JFK. And the trip had a particularly disheartening outcome for Lee: None of the people he was supposed to meet, who would ensure that the cancer infection was sent into Cuba, showed up. So it was a very frustrated Lee Harvey Oswald who returned to New Orleans to learn that the plans to assassinate Castro using cancer had been shelved. Judyth's services were no longer wanted, and Lee was ordered by his employers to travel to Dallas, where he found work at the Texas

School Book Depository. Thus, both Judyth's and Lee's roles in the plot to assassinate Fidel Castro became history. Their paths diverged, to the immense sadness of both of them, and they never again saw each other face to face after they said goodbye in August 1963.

Catastrophic consequences for the prevalence of cancer worldwide.

The consequences of the American research to develop cancer into a possible murder weapon are difficult to predict. But if Judyth Vary Baker is right that cancer is caused by a virus, then there can hardly be any doubt that the many types of cancer virus developed in the secret medical projects in New Orleans must have begun to take on a life of their own once they were created. If this is the reason for the enormous number of people affected by cancer in our time, it is a horrible thought. It is unlikely that anyone could have foreseen the terrible consequences of their experiments.

According to Judyth, there was also a tremendous belief that cancer drugs would soon be developed so that the disease would not pose a threat to humanity in the future. But as we know: It didn't work out that way. Attempts were made to remove all traces of the research, and one of the foremost scientists, who led the work of mutating the cancer cells after Judyth had grown the most dangerous cells, was murdered a few years later, like so many others who had played a role in dubious and secret American projects.

Lee Harvey Oswald infiltrates anti-Kennedy groups and reveals assassination plans.

Although Lee and Judyth didn't see each other again after they parted ways in New Orleans, they spoke up to 14-15 times on the phone during the time Lee worked at The Texas School Book Depository. According to Judyth, Lee became increasingly agitated and almost desperate during this time. He is said to have infiltrated circles involved in the planning of Kennedy's assassination, and it is said that Lee's warnings of an impending assassination attempt in Chicago led to Kennedy's planned trip there just a few weeks before the assassination in Dallas being canceled just hours before the president's departure. It has long been known that a person named "Lee" warned of the assassination plot in Chicago, without anyone knowing who he was.

But in Dallas, Lee realized that he was in fact in a very dangerous situation, as he was playing a deadly double game, infiltrating circles where a human life had very little value, while at the same time wanting to inform those who had the power to prevent the assassination. What Lee probably didn't realize was that even within the CIA, FBI and Secret Service there were

people in league with the assassination planners, and whether or not Oswald actually managed to deliver warnings of an impending assassination, these could just as easily have ended up with those who actually participated in the planning of the assassination.

According to Judyth, Lee knew full well that his life was in danger, but he considered it much better that he remained in his position, as it could have even more disastrous consequences for himself and his family if he pulled out at the last minute. For that, he knew far too much about who was behind it. Lee mentioned several names to Judyth in the final phone call, all high-ranking people in the circle around Lyndon B Johnson or in the CIA. What's more, a resigned Oswald thought it would be better if he sacrificed his own life if he could save the life of the President of the United States. This made Judyth unspeakably sad, and they both cried as they ended their very last phone call.

The man who tried to prevent the murder is identified as the killer!

The deeply tragic thing that happened was that the man who risked his life to prevent the assassination of John F. Kennedy was himself identified as the killer! It must have been with deep despair that Lee Harvey Oswald realized that he was ultimately left as the scapegoat. Lee had involved himself with people who willingly used others to achieve their goals, even if it meant death for the victims.

Oswald understood that his life was in danger after the murder, but according to the most reliable sources, Jack Ruby gave him a gun outside the school bookstore, so he probably figured he could defend himself before going to the movie theater where he in all likelihood was expecting to meet one of his contacts, or would otherwise find an instruction from his employer.

But there the police were waiting for him, obviously tipped off as to where Oswald would be. Oswald must have been deeply shocked when the charges against him became apparent to him. But he retained his composure in a remarkable way, and if you read all of Oswald's recorded statements after his arrest, it testifies to a man who is clearly innocent, in my opinion.

Perhaps it can be seen as an irony of fate that Judith Vary Baker, who refused to participate in the testing of cancer cell injections on unwitting people, survived, while Lee Harvey Oswald, who participated in deadly experiments and went all the way to carry out his role in the planned assassination of Fidel Castro, himself fell as a victim in an assassination plot against the American president.

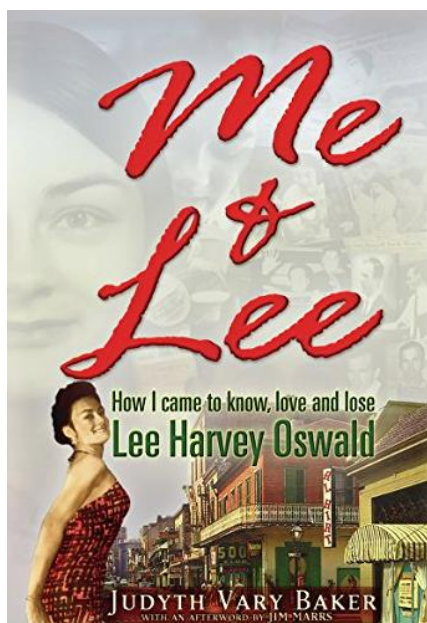
In any case, we owe Judyth Vary Baker a debt of gratitude for sharing her story with the world. A few weeks after JFK's assassination, David Ferry called her and told her that if she wanted to keep her life, she had to remain silent about her knowledge, nor could she become a public figure. Her only option to avoid being murdered was to live a secluded and anonymous life.

But after her children had grown up, she was no longer able to keep her knowledge to herself, but chose to go public with it, and she was almost immediately exposed to threats, but has chosen to defy them at the risk of her own life. Hopefully, she can serve as a role model for more of those who have first-hand information about JFK's murder and who have not yet spoken out publicly.

JFK assassination: New eyewitnesses come forward!

In debates about who murdered JFK, I'm constantly asked why more witnesses don't come forward and tell what they know. In recent years, more and more eyewitnesses have made their knowledge public, and it is becoming increasingly difficult to deny the facts.

Not long ago, I told you about the sensational book by former cancer researcher Judyth Vary Baker, "Me & Lee: How I Came to Know, Love and Lose Lee Harvey Oswald", in which she recounts her close relationship with Lee Harvey Oswald in the spring and summer of 1963, and her role in cancer research and the CIA's plans to assassinate Fidel Castro using biological weapons.

She has recently published another book about David Ferry, who many people who saw the movie JFK remember well as a somewhat bizarre character who was murdered just before he was due to testify in court about his involvement in the assassination of JFK.

With the publication of these two books, no one can now argue that no eyewitnesses to the conspiracy that led to the assassination of the US president have come forward, and that the conspiracies are therefore just fantasies. I have ordered both of Judyth Baker's books from the USA, and have based my assessments so far on a large number of interviews with her that are

available on YouTube, as well as personal contact with her through Facebook.

Judyth has spent the last few years in Europe because her life was threatened in the United States after she came forward with her story, but is now back in her home country to, among other things, arrange various conferences in connection with the anniversary of Kennedy's assassination, which took place on November 22, 1963.

But Judyth Baker is not the only credible witness who has come forward in recent years to tell her story of how the CIA/FBI informant, Lee Harvey Oswald, through hitherto unknown circumstances, found himself in the middle of a circle of people who planned the assassination of the President of the United States.

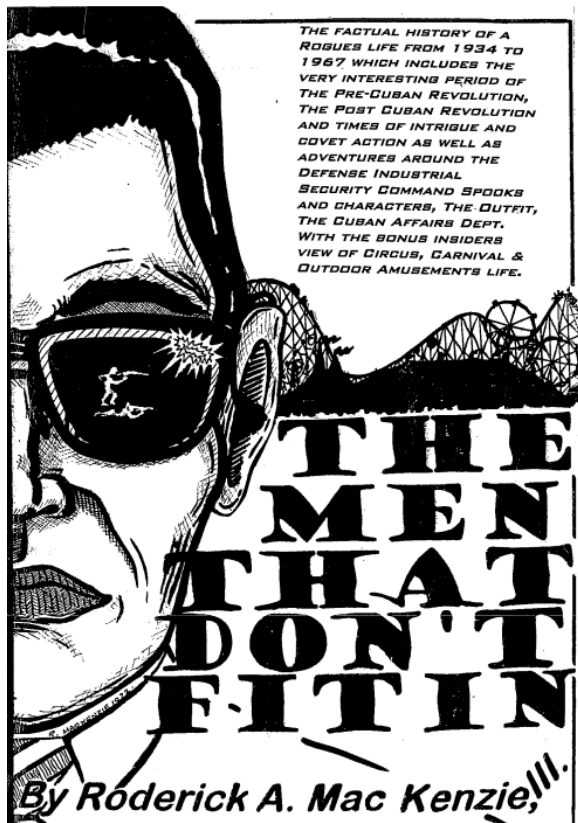
Lee Oswald had been an American spy in the Soviet Union, and when he returned to the US, he became involved in the CIA and the mafia's plans to assassinate Fidel Castro. New Orleans was the scene of experiments to develop cancer cells as a possible biological weapon to assassinate Castro, but the plans were eventually shelved and the same people involved in this assassination plot now turned their attention to planning the assassination of the President of the United States, who was extremely unpopular with the CIA, the FBI, the Cuban exiles, the arms industry, the oil moguls and the national bank. Kennedy had challenged virtually all the power centers in the US economic and political elite, and made enemies in very powerful circles. And all of these power centers saw it in their interest to get rid of Kennedy and replace him with Lyndon B. Johnson, who had usurped the vice presidency thanks to outright blackmail from FBI chief J. Edgar Hoover.

Judyth Baker recounts her knowledge of these events in great detail, and her story can be documented down to the smallest detail. She developed an intimate relationship with Lee Oswald in New Orleans through their joint participation in the CIA plans to assassinate Castro, and Judyth tells how in the summer of 1963 Lee Oswald was ordered by his employers to Dallas, and was given work in the school book depository on Elm Street,

But what Oswald didn't know was that his employers no longer regarded him as an important informant, but planned to pin the blame on him as the lone, half-mad gunman who assassinated the President of the United States, motivated by his Soviet communist sympathies and admiration for Castro. In reality, Oswald had been an American spy in the Soviet Union and hoped to continue his career as a spy in Cuba. And everything indicated to Oswald that he was being systematically built up as a future American spy in Cuba.

But the CIA/FBI had other plans for the somewhat naive Oswald. As the plans to get rid of the US president emerged, they needed a scapegoat who could be accused of being the lone assassin, and Oswald emerged as a perfect candidate to be used as a "patsy". What had previously been his cover story, communist sympathizer and Castro admirer, could now be used against him for all it was worth, and it is in the nature of things that such a cover story cannot be disproved, because the spy must not be revealed.

Judyth Vary Baker describes in detail her intimate relationship with Oswald and how he became more and more closely entangled with a group of people who were to participate in the assassination of John F Kennedy in Dallas on November 22, 1963. But Oswald's motive for participating in this plot was to try to prevent the assassination from taking place by informing the CIA and FBI about the plans that were being developed. But as we all know: Oswald's intentions failed completely, and he himself was declared the lone assassin. But as he himself said to the entire US press corps and on live TV: "I'm just a patsy!"

Judyth Vary Baker is not the only witness to come forward these days. Even within the mafia, there are people who want to share their knowledge with posterity, and one of these is the street-level mafia enforcer, Roderick A. MacKenzie. MacKenzie. He had no power within the Mafia, he was not involved in the plans to assassinate the President of the United States, and he does not compromise himself by revealing his knowledge of the assassination. The mafia had a number of accomplices at lower levels. Half- and full-time criminals who were content to carry out orders and not question their intent. Roderick MacKenzie was one such mafia henchman. He was a semi-criminal who early on specialized in producing false papers and ID cards. And if there was one thing the mafia needed, it was just such knowledge. Through his loyal work, MacKenzie was clearly considered a useful man for the mafia, and in the fall of 1963 he was asked to manage one of the mafia's hideouts in Dallas - a so-called "safe place".

MacKenzie had no idea what the hideout was for, but carried out his orders loyally, and it was only in retrospect that he realized he was actually the manager of the hideout for a large group of people involved in the assassination of the President of the United States. MacKenzie wrote down his story and illustrated it, and had the book printed as a booklet. The booklet is available online.

I can promise anyone who reads my article that it is worth the time to read MacKenzie's story. He comes across as a semi-criminal, rather unscrupulous and immoral person, but with so much credibility that it is difficult to dismiss his story out of hand. And his story has been analyzed and evaluated by serious Kennedy researchers in the United States, and his story has been investigated by seeking out people who are specifically named as participants in the shooting teams that were set up to participate in the assassination. And up to several of the

shooters admitted their participation before their death.

According to MacKenzie, several teams of gunmen were placed in various positions around Dealey Plaza, and the entire operation was administered from the school book depository where Oswald was employed. The team that administered the assassination consisted of four people, all named by MacKenzie, and one of these was the man who later assassinated Lee Harvey Oswald, Mafia man Jack Ruby. Oswald himself had infiltrated the shooting team located on the sixth floor of the school book depository, and according to him, he was offered the opportunity to fire shots at the president, but he declined. His only motive was to prevent the assassination from taking place. One of the shooters located in the “sniper's nest”, the place proclaimed to be the lone gunman's position, the 6th floor of the textbook warehouse, Mac Kenzie reveals, was Malcolm “Mac” Wallace, a close associate of Lyndon B. Johnson. In retrospect, it has been documented with great certainty that his fingerprints were found on one of the cardboard boxes in the “sniper's nest”.

In addition to the shooting team in the school book depository, there were shooters all around Dealey Plaza. Shooting teams of four to five people were formed, and according to MacKenzie, each participant received \$10,000. This was a considerable sum for more than 20 participants, but funding had been obtained from some of America's richest oil moguls and arms manufacturers, whose income would be drastically reduced if Kennedy's plans were implemented. The shooting teams were both behind and in front of the presidential car, and the driver ensured that the car was slowed down and almost stopped when the car was in the perfect position for the shooters in front of Kennedy to hit Kennedy with fatal shots. And anyone who has seen the so-called Zapruder film showing the assassination will see that Kennedy is hit from the front and that his head is brutally thrown backwards. It is completely impossible that he could have been hit in the head from behind. Kennedy was definitely hit in the head from the front, and that rules out Oswald as the shooter.

But if MacKenzie was just a low-level mafia associate, how on earth did he know so much about the details of Kennedy's assassination? Well, because one of the key players in the planning of the assassination, the man known as LBJ's hitman, Mac Wallace, “unloaded” on MacKenzie the day after the assassination. Wallace was highly drunk and loose-mouthed, boasting unrestrainedly about the murder, and clearly did not consider it particularly risky to reveal the details of the murder to the insignificant, subordinate person. Or he was so drunk that he was unable to realize the risk he was exposing the plot to. In any case, MacKenzie wrote down the names he was given, and some of them have subsequently admitted their participation in the murder plot.

Several of the more than 20 people listed as participants in the shooting teams have yet to be investigated. MacKenzie had to rush into the bathroom to write down the names so he wouldn't forget them, and he didn't dare write them down in front of Wallace's face. Of course, something could have gone wrong. For example, Roger Craig is listed as a shooter, but that must be a mistake, because hardly anyone believes he was anything other than a law-abiding policeman. He was subjected to several assassination attempts, and was eventually murdered, and in usual mafia fashion, it would appear that he committed suicide. But very few unbiased researchers believe that.

But what is absolutely certain is that a large proportion of the people who, since 1963, have achieved key positions in American politics and economics were informed that Kennedy would be assassinated. Like slobbering dogs, they stood ready to assume powerful offices as a reward for keeping quiet about their foreknowledge of the assassination. One of those

MacKenzie observed in the hideout he managed in Dallas in 1963 was later US President Richard Nixon. And key Kennedy scholars question the role of CIA Director and President George Bush Sr. in 1963. President Glenn Ford famously participated in the Warren Commission's gigantic cover-up, in which outright lies and falsification of evidence were used to “prove” that Lee Harvey Oswald was the lone gunman. A disgrace in the history of the United States, where powerful people who participated in the conspiracy still rule the world's most powerful country.



Many claim that Jack Ruby could not have known when Oswald was to be taken out of the police station and down to the waiting car that would take him away. The time was postponed, and Ruby is said to have walked into the basement, where the car was waiting, only a short time before Oswald was taken out. What's more, a receipt from the post office was found nearby, with a time stamp to prove that Ruby was there at the original time of Oswald's deportation. He stands ready to wait for a signal for Oswald to be taken down to the basement, and many believe that signal was the man in the light-colored suit escorting Oswald. He can be seen in the picture above, where Ruby shoots Oswald. It would be very easy to see him through the windows as they moved towards the exit. And one might ask: How on earth could a mafia member and criminal bar owner be allowed to stroll undisturbed into the police station as the heavily guarded suspect in the assassination of the country's president was being transported out? The assassination of John F. Kennedy was a coup d'état - staged by the American establishment.

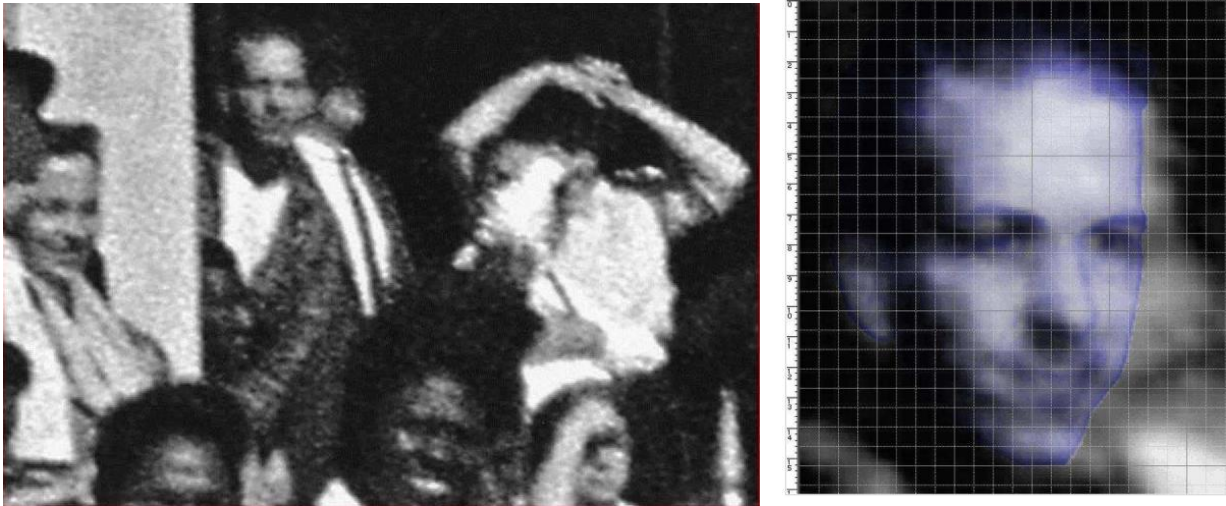
November 22, 2019 marks 56 years since Americans got rid of their former president in a public execution broadcast live on TV, with blood and brain matter splattered across the car, the street and people nearby. In today's United States, where the polarization between Democrats and Republicans is perhaps greater than ever, one should perhaps fear that both current President Joe Biden and his challenger, former President Donald Trump, are in great danger of being assassinated, but it seems that those days are gone when the entire American establishment could get behind an assassination of the President of the United States. It was easier just over 50 years ago. You could simply assassinate the president, and the entire establishment was ready to cover up the murder and blame it on a single “lone nut”, as former President George W. Bush called the alleged shooter Lee Harvey Oswald in his speech at Gerald Ford's funeral, while grinning broadly. He knew full well that Lee Harvey Oswald was an innocent patsy!

Large parts of the American public refuse to believe that Kennedy was murdered by a “single lunatic”, and a US congressional committee from 1979 concluded that Kennedy was murdered as a result of a conspiracy, but this conclusion does not seem to have found its way into either the American or Norwegian media. Every time the case is mentioned in public, Lee Harvey Oswald is referred to as the lone gunman. The truth is that Oswald did not fire a single shot. He was standing in the doorway in front of “The Texas School Book Depository” when the motorcade passed and Kennedy was shot. Both photos and films that have emerged in recent years show Oswald standing in the doorway and then moving down the stairs and out into the square in front of the school book depository. For those who want to familiarize themselves with the discussion about the images of Oswald in front of the school book depository at the same time as Kennedy was shot, I can inform you that he is often referred to by researchers as “the doorman”.



The photo on the previous page was taken by Associated Press photographer James Altgens in the seconds after Kennedy was shot in the neck. Enlargements of the image clearly show that Kennedy has raised both arms up in front of him as if to protect himself from more shots from the front. Would a person shot from the front raise their arms in front of them to protect themselves? I don't know for sure, but I find it highly doubtful. In all likelihood, Kennedy was hit by a shot from the front, which hit him in the throat and caused an exit wound in the neck/back. Initial witness observations from a large number of doctors, nurses, ambulance drivers and anesthesiologists at Parkland Hospital, where Kennedy was transported, identified the throat wound as a small entry wound from the front. But the Secret Service commandeered the body for an autopsy under their control at Bethesda Navy Hospital, and the photos from there show a large wound in the throat. What happened in the meantime that made the wound so large?

And why is it so crucial if Oswald can be positively identified as the man standing in the doorway in front of the school book depository? Because it makes it impossible for him to be on the sixth floor at the same time as shooting the President! Oswald himself claimed that he was standing in the doorway and this has been confirmed by several witnesses.



On the left: An enlargement of Altgens 6, showing some of the people standing in the entrance to the textbook warehouse when Kennedy was shot in the throat. The man in the corner is often called “the doorman”. On the right: In 2015, Kennedy researcher Larry Rivera conducted a thorough examination of the face of “the doorway man” using modern forensic facial recognition techniques. With the help of so-called picture overlaying, he established with great certainty that the doorway man was Oswald and not Billy Lovelady, who also worked in the schoolbook warehouse and is claimed by many to be the doorway man. And not without reason, he resembled Oswald both in dress and appearance. But Lovelady's shirt had a very different pattern, and I think Rivera is absolutely right in his conclusion.

And there are also several films that sweep past the entrance to the school book store, and the films taken by Wiegman and Darnell also show a man in the opening, standing a little further back, in the shadows, and appearing to drink from a bottle. Researchers call this person “the prayer man” because of the way he holds his hands. Several highly skilled Kennedy researchers believe that this is Oswald, and I rely on [Bart Kamp](#) who has provided some very insightful analysis in his book [Prayer Man: More Than a Fuzzy Picture](#).

Bart Kamp's strength is that he has compared a large number of photos and films with the statements of the various people, and in this way he has managed to identify the vast majority of those standing in and around the entrance to the school book depository. And Bart Kemp has identified Lee Harvey Oswald with a fair degree of certainty as both “the doorway man” and “the prayer man”, and even identified Oswald's Coke and lunch bag, which was left behind in the corner.

Those who are critical of the Kennedy research often call what is presented mere conspiracy theories. But they seem to forget that the US Congress already concluded in 1979 that Kennedy was assassinated as a result of a conspiracy. In my view, the term “conspiracy theory” was invented by people who want to devalue research that reveals that governments and military organizations such as the CIA and FBI have been involved in assassinations of heads of state and coups in other countries as “just” conspiracy theories. However, those who have conducted in-depth research into US interference in the internal affairs of other countries have found both predatory assassinations of political leaders and highly unethical actions that have triggered acts of war in the belief that the provocations were carried out by political enemies, while in reality it was the CIA that was behind them.



The sharpest enlargement I have seen of the prayer man. Although blurred, it has all of Oswald's characteristics, and you can see quite clearly the Coke bottle, which he talked about in his statement, and which was seen by a witness.

In the decades after World War II, during the Cold War, the CIA had its own assassination squads, assassins and firing squads that executed left-wing foreign leaders and removed unwanted politicians. These cases must be considered in light of the Cold War, where the US was terrified of communist world domination.

And when the revolution turned Cuba into a communist supporter of the Soviet Union, the CIA, the mafia and the Cuban exiles in the USA had common interests, they were connected and established a collaboration that came in handy when they wanted to assassinate the president. They eventually discovered that they also had common interests in getting rid of the US president. The Mafia felt that the President, through his Attorney General, Robert Kennedy, was trying to break them.

The CIA fought for its existence when the president fired their leaders and wanted to dissolve them after the failed invasion of Cuba, and the Cuban exiles hated the president because he showed indifference to Cuba's communist regime. Cuba had been a haven for the mafia and the wealthy part of Cuba's inhabitants for casino operations and the alcohol trade, which brought in gigantic sums. With Castro, a paradise for the mafia disappeared.

But these weren't the only groups that were furious with Kennedy. The dictatorial head of the

FBI, J. Edgar Hoover, considered Kennedy a security risk because of his many affairs with women, including women who were also the mistresses of mafia leaders.

Kennedy challenged the large and powerful power centers in the US, and they came together in a desire to get rid of Kennedy and install the far more amenable politician Lyndon Baines Johnson, who during his presidency built up enormous fortunes on investments in both the oil and arms industries. One of the first things Johnson did as president was to escalate the war in Vietnam, and Kennedy also had plans to tax the oil industry more heavily, he wanted to limit US warfare, including in Vietnam, and he wanted to change the entire monetary policy in the United States and deprive private actors of the opportunity to make huge profits from printing money. In short, John F. Kennedy was an exceptionally idealistic president who threatened both the economic and political power of many while at the same time withdrawing all of Kennedy's plans to deprive the oil and arms industries of their power. It is also known that Johnson invested heavily in the industries he knew would yield enormous profits. Johnson's descendants today benefit from Johnson's enormous fortune, as do the families of the vast majority of American presidents.

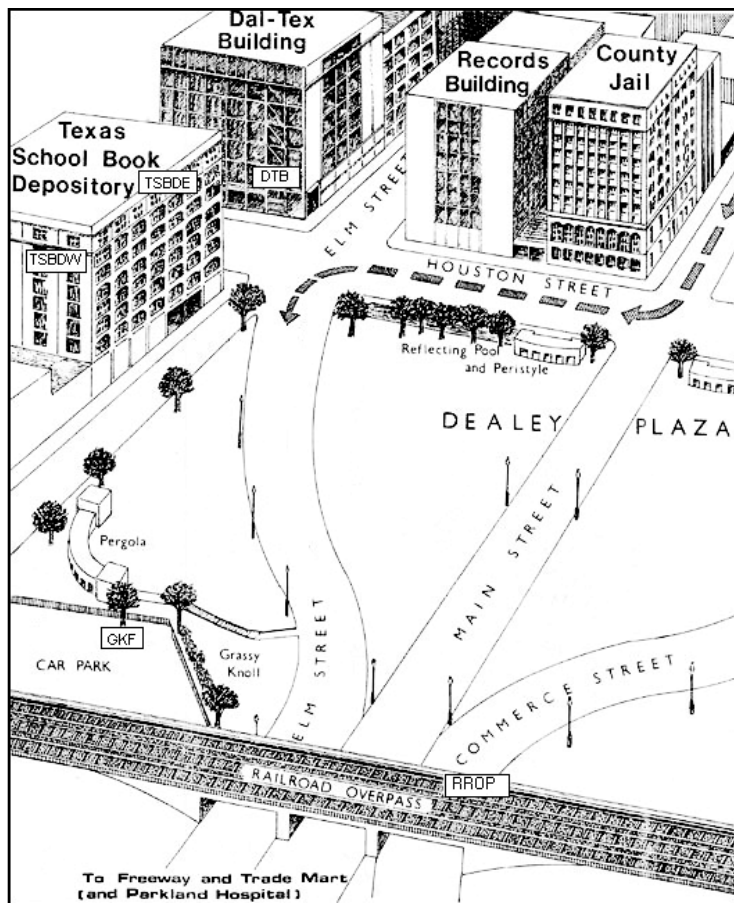
The day before Kennedy's assassination in Dallas, a meeting was held at the home of one of Texas' most powerful men, oil mogul Clint Murchison, in his mansion not far from Dallas. We have several witnesses who can confirm this meeting, and the gathering consisted of most of the key people who wanted Kennedy assassinated, including the head of the FBI, J. Edgar Hoover, leading figures in the CIA, oil and arms moguls, representatives of the economic elite, Republican Richard Nixon and Vice President Lyndon B. Johnson. Johnson's mistress said that Johnson was ecstatic after the meeting and promised her that the Kennedys would never bother him again. At the meeting, the assembly agreed that the best thing for the United States was for the president to be assassinated, and that the assassination should be carried out as planned the next day, during the motorcade in Dallas.

All the preparations were made for the assassination to be carried out on Elm Street in front of The Texas School Book Depository, where CIA agent Lee Harvey Oswald had been ordered by the CIA to work, so that he could be used as a “patsy” and blamed as the “lone gunman”. The shooting teams had been assembled and paid for by the oil millionaires, their place in the ambush was clear and plans had also been made in minute detail how Lee Harvey Oswald was to be singled out as the lone, mad shooter with communist sympathies. In reality, Oswald was a highly trusted CIA and FBI agent and had been a spy for the US in the Soviet Union for several years. But his stay there now became something the CIA and FBI planned to use against Oswald, to portray him as a communist sympathizer.

If American intelligence was convinced that Oswald really was a communist sympathizer, they would obviously not have allowed him to return to the USA and regain his American citizenship so easily. And least of all would they have allowed his Soviet wife to enter the USA with him. Experienced agents who have studied Lee Harvey Oswald's life tell us that he has absolutely all the characteristics associated with a secret agent.

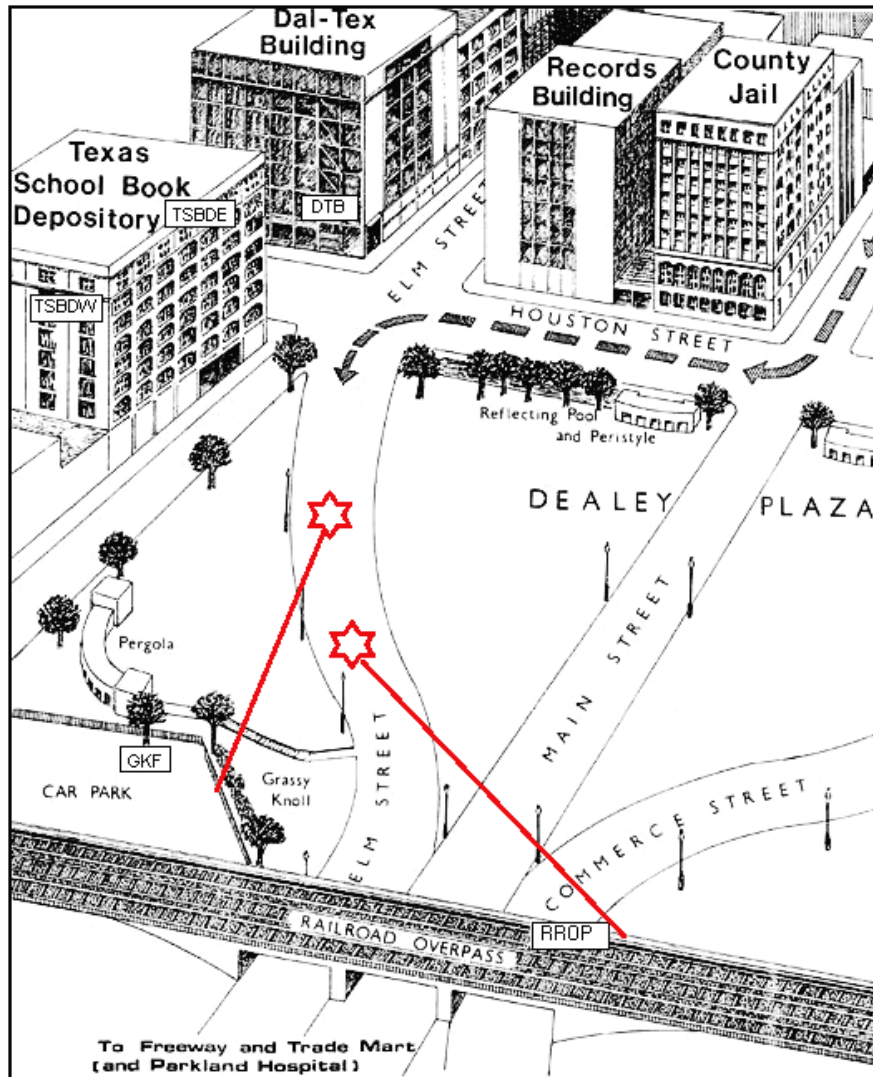

Very few of them were referred to in the Warren Commission report, which claimed that there were no credible witnesses who heard shots from the front. Still image from the internet.



Drawing showing where the firing teams were deployed in Dealey Plaza. It was the perfect location for the assassination of the President of the United States. After the 90-degree turn from Houston Street onto Elm Street, the speed of the car was very low, and many witnesses said that the limousine almost came to a full stop just before Kennedy was hit by the head shot that put a final end to his life. The president was fired upon from all sides. Two shooting teams were located on the 6th floor of the textbook warehouse, (TSBDE and TSBDW) one team was on the second floor of the Dal Tex building (DTB), several shooters were on the grassy knoll (GKF) and the same at the south end of the railroad crossing (RROP). A shooting team was also supposed to be ready with their rifles on the roof of the Dallas County Records building on Houston Street, but they were prevented from getting into position, so no shots were fired from there. Little did John Fitzgerald Kennedy know that a total of six shooting teams, consisting of more than 20 assassins, were waiting for the car he was sitting in to arrive at Dealey Plaza, and would fire at him in a crossfire scenario with shots from all sides - from behind, from both sides and from the front. Two shooting teams were deployed on the sixth floor of the textbook warehouse, one at each end, one shooting team on the grassy knoll, one shooting team in the Dal Tex building, one shooting team in the Dallas County Records Building (this team never got into position at the top of the building and did not fire any shots) and one shooting team in what is known as “the south knoll” or “the railroad overpass”. And the shooters were among the best the CIA, the Mafia and the Cuban exiles could muster. In reality, Kennedy was sentenced to death as the motorcade began its drive from Lovefield Airport through Dallas. Both film and images clearly show how the Secret Service agents who were supposed to protect the president are ordered to leave the car unprotected. The assassins' plans were made down to the smallest detail, the shooters were ready in their positions and, not least, everything was set up to lay the blame on a lone, “insane” shooter, Lee Harvey Oswald, who in reality was a very loyal and devoted agent of the United States and someone who loved the President of the United States and would do everything he could to save the President's life. He did just that on one occasion. The President's planned trip to Chicago with its motorcade was stopped at the last minute, thanks to a warning from a certain Mr. Lee. Lee. It is also known that Harvey Oswald tried to warn the FBI about the plot against Kennedy in Dallas, but the warning never reached those who could have saved the President's life.



It should be obvious to anyone investigating the case that both of the two shots that hit Kennedy came at an angle from the front, from two different positions. The shot that hit Kennedy in the neck and made an exit wound at the top of his back, came from the so-called “grassy knoll”, and a large number of witnesses said they heard shots from here and saw smoke from the shot. And after the series of shots, a large number of witnesses ran up to the grassy knoll to see if they could find the shooters. When the second shot hits Kennedy in the head, he has turned slightly to the left, and the shot hits him on the left side of the forehead, making a large crater on the left side of the back of his head. The bullet must have been a so-called expanding bullet, because Kennedy's head almost explodes and blood, brain matter and bone fragments are thrown into the car, out into the road and towards the motorcycle police coming up behind the presidential cars. Several large pieces of the skull are only attached by the skin, and later, when pictures are taken of Kennedy during the autopsy, these pieces are held in place so as not to reveal how enormous the injuries actually were. 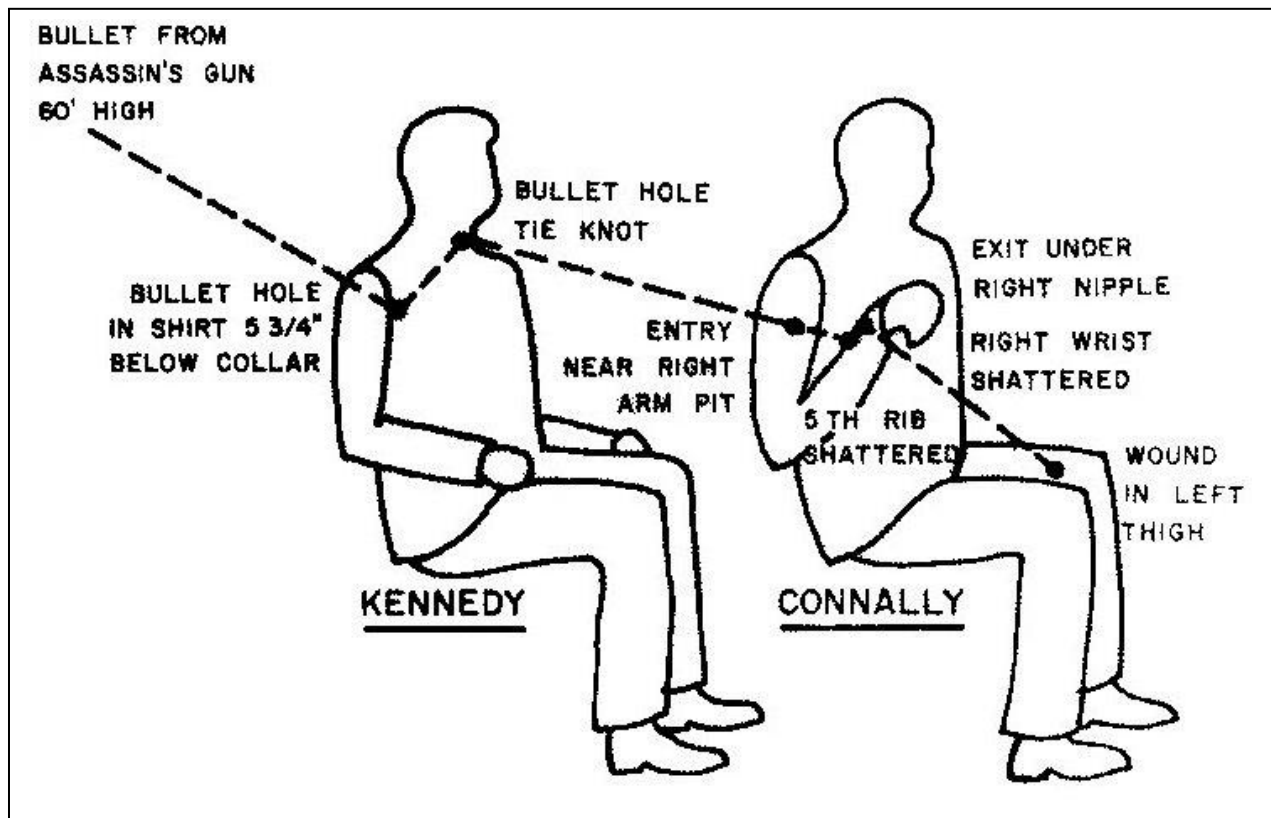
But why isn't everything I'm talking about here known through the media, either in the US, Europe or Norway? Well, the media in the United States is largely responsible for the fact that the truth about the murder of their own president has not been known. It was only during a few hours after the assassination that the media reported from different sources with different information. But after a few days, the “truth” was established and all the information was coordinated. The

weapon was stated to be an Italian-made Mannlicher Carcano, purchased by mail order from a certain Alek James Hidell, who the authorities later “proved” was Lee Harvey Oswald. In reality, the Carcano rifle is an exceptionally poor weapon, highly unreliable, slow and difficult to load and no one could have managed to fire three deadly shots in such an extremely short time with this fragile rifle - only about six seconds. And if Oswald really was the killer, he must be considered the stupidest perpetrator in world history. He left his murder weapon at the scene, three empty shells and “proof” that he had bought the weapon by mail order, whereas he could have walked into any gun shop and bought a rifle without identifying himself. But Oswald, who was a highly trained agent, chose to leave behind evidence that identified him as the killer?

What's more, many of the witnesses heard far more than three shots - but it had been decided in advance that three shots fired from behind would be the official story, so three casings were left behind. But after three shots, Kennedy was barely injured, so more rounds were fired, and many of the witnesses heard that. Therefore, at least eight shots sounded in Dealey Plaza, and it became relatively difficult to hide this from the public. The same with the obvious fact that Kennedy was hit from the front, while the official story was that he was hit from behind by a lone gunman, who only fired three shots at impressive speed, and that while the victim was hidden behind a large tree. The official autopsy commissioned by the CIA at Bethesda Naval Hospital had a very difficult job ahead of them, preparing Kennedy's body to look as if he had been hit from the front. But those who saw the unprocessed body at Parkland Hospital, where Kennedy's body was first examined, and there were a significant number who saw the body, told the unvarnished truth: Kennedy had been hit from the front in both the neck and forehead. He had an exit wound in his neck/back and an exit wound, a fist-sized hole, in the back of his head from an expanding bullet that had almost caused his head to explode. Parts of Kennedy's skull were only attached thanks to the scalp, and could be tilted up and down.

Most of Kennedy's brain matter and pieces of his skull remained in the limousine or on Elm Street, and the blood spatter had hit the motorcyclists riding behind Kennedy. That he was hit from the front is also confirmed by the so-called Zapruder film, which clearly shows Kennedy being knocked backwards as the headshot hits. Claiming that this shot came from behind is meaningless! Kennedy's brain was stolen, some say. The truth is that the exploding skull caused Kennedy's brain to be scattered across Elm Street. Nevertheless, the area was not cordoned off as was standard procedure for a crime scene. A remarkable omission on the part of the Dallas police, which contradicts all existing police instructions! Can it be proven more clearly that the Dallas police were involved in the plot? It is said that even several days later people could find pieces of Kennedy's skull at the scene! Moreover, when a person came forward very early in the investigation, James Tague, who could document that he was almost hit by one of the shots, the investigators had to make up what must be the most improbable story about how a bullet can change direction up to several times, go up and down, to the side and back again, so that the story of three shots against the president could be maintained.

Anyone who wants a good laugh is advised to read the story of “the magic bullet”. It's rare to hear worse nonsense from responsible authorities and investigators. The fact that this nonsense was accepted by the authorities, the investigators, the media and the public says a lot about how extraordinarily easy it was to get everyone to accept the official story of three shots



The official explanation for Kennedy's assassination was predetermined, and it would be that three shots were fired from behind. Therefore, three blanks were placed in the sniper's nest on the sixth floor together with the Italian-made rifle to ensure that Lee Harvey Oswald was considered the lone gunman - "the lone nut" as George Bush called him in a speech. However, that explanation was in danger of being seriously shattered when James Tague, standing by the triple underpass, alerted several journalists that a shot had hit the ground directly in front of him, causing stone particles to hit him. The conspirators were therefore forced to come up with a completely new explanation, and the solution was a highly remarkable theory that the projectile from one of the shots from behind had changed direction several times, injuring both Kennedy and Connally in a large number of places. Fortunately for James Tague, his observations were shared with several journalists soon after the assassination. Fortunately, new witnesses and new information are constantly emerging from people who only later dared to come forward with their information about the Kennedy assassination. It was well known in the aftermath of Kennedy's assassination that certain death awaited all those who came forward and testified about events that went against the official story. And dozens of "unexplained" deaths can subsequently be linked to the Kennedy assassination.

In particular, I would like to point to two very credible and reliable witnesses. In particular, Judyth Vary Baker, who has written two books about her role and that of many others in the events leading up to Kennedy's assassination.

She was Lee Harvey Oswald's mistress in the period before the assassination and collaborated

with him in New Orleans where, as a cancer researcher, she was engaged in a project to possibly develop cancer as a biological weapon, and Lee Harvey Oswald was an observer of the experiments on behalf of the CIA. The cancer cells being developed were intended to be used as an assassination weapon on Fidel Castro, and Oswald was in Mexico to hand over this advanced biological weapon. But the recipient never showed up, according to Vary Baker.

It shouldn't surprise anyone that the US was conducting such experiments. Incidentally, the fiery and highly potent cancer cells were in all likelihood used for injections by Jack Ruby, the Mafia man who had to sort out the failed attempts to assassinate Lee Harvey Oswald before he was arrested alive, and shot him on live TV. The intention, of course, was to shoot Oswald as he “resisted arrest”, but that obviously failed, so Ruby had to complete what the arresting officers had failed to do. And then Ruby himself had to be put down. He died in prison in 1967 of cancer.

Judyth Baker's books are extremely compelling and contain a wealth of documentation that proves her story to be true. She spoke to Lee Harvey Oswald just days before his death, and she tells us that he was fully aware that his life was in great danger. He also knew that both his wife and their children would be killed if he resigned. He tried to prevent the murder until the very end by alerting the FBI.



Previous page: A large number of doctors, nurses, paramedics and anesthesiologists were present at Parkland Hospital, which received President Kennedy shortly after the assassination. Even doctors who were busy with other activities went to the emergency department to see if they could help. What everyone who examined and observed the severely injured President Kennedy had in common was that they all testified afterwards that they had seen a fist-sized exit wound in the back of Kennedy's head. They also said that the wound in Kennedy's neck was a small entry wound from a shot fired from the front. This strongly contradicted the Warren Commission's report, which completely disregarded all these first-hand observations. And what came out of this autopsy told a completely different story than what the large number of doctors and other staff at Parkland Hospital who received the severely injured Kennedy. The other very credible witness who has come forward is mafia member Roderick A MacKenzie III, who has written a very convincing book entitled “The men that don't fit in”. MacKenzie was a lower-level mafia member who performed important tasks for the mafia without knowing much about their activities. Among other things, he was a highly skilled forger of documents and produced everything the mafia wanted in the way of false ID cards and the like. In the time before Kennedy's assassination, MacKenzie was commissioned to organize a so-called “safe house” in Dallas, without knowing anything about what it would be used for. A “safe house” is a hiding place for the mafia in connection with an operation, and all traces were erased after the operation was over. MacKenzie was used to carrying out his missions without asking any questions and set up the safe house in Dallas. He observed who came and went and who stayed in the various rooms in the days around November 22, 1963, and he was also assigned to observe the hospital where Kennedy had been autopsied after the assassination, to alert the mafia if anyone asked suspicious questions. In that case, the individuals would be strongly warned or murdered by the Mafia, as they did with anyone who came forward in public and questioned the “lone nut” theory.



Two first-hand witnesses to the events in The Dalles in 1963. On the left, Judyth Vary Baker and on the right Roderick MacKenzie III. Both have written about their experience with startling new information. Judyth Vary Baker collaborated with Lee Harvey Oswald in a biological experiment aimed at killing Fidel Castro, and became Oswald's girlfriend. MacKenzie was a lower-level mafia member who was surprisingly told about the events by a drunken mafia member.

MacKenzie's book contains many important details about Kennedy's assassination, particularly because one of those responsible for the shooting teams, Vice President Lyndon

B. Johnson's good friend and “hitman”, Mac Wallace, revealed important details about the assassination plot to Mackenzie while drunk. He recounts all this important information in his book. Among the mafia, the murder plans went under the name “the hit parade”. “The big event” was also an expression used to describe the murder among those involved.

But Vary Baker and MacKenzie are not the only new witnesses to the Kennedy assassination. There are more who are gradually daring to come forward and tell what they know. One of the shooters in the textbook warehouse, Loy Factor, has also admitted that he was there and that he shot at Elm Street, but did not want to assassinate the president. This explains why a number of the shots do not appear to be real attempts to hit Kennedy but hit the asphalt and grass next to the limousine. Something that supports Mackenzie's story is that Mac Wallace's fingerprints were found on one of the cardboard boxes in “The Snipers Nest” at the south end of the textbook warehouse, where a hiding place had been built using empty cardboard boxes. According to MacKenzie, Wallace played a very important role in the murder plot as he was responsible for the composition of the shooting teams.

Every year, Judyth Baker organizes a conference in Dallas on the day of the horrific assassination of the President of the United States, and the conference features highly educated and insightful people. Many of them are among the finest scientists and women the US has to offer. The power elite's dismissal of these people as frivolous proponents of easy conspiracy theories simply does not hold water. It's time for America and the world to know the truth about how the American establishment got rid of John F. Kennedy. And the establishment includes Vice President Lyndon Baines Johnson and the politicians around him, the CIA, the FBI, the arms industry, the oil millionaires, the Secret Service, the mafia and exiled Cubans.

In addition to Lyndon B. Johnson, American presidents who either participated in or knew about the assassination include George W. Bush, who was a CIA employee in 1963 and probably played an important role in organizing the murder, Richard Nixon, Gerald Ford and George Bush Jr. There is footage and photographs that in all likelihood show Bush Jr. in Dealey Plaza during the assassination. And his father must be the only person in the United States who does not “remember” where he was when the assassination took place. President Gerald Ford played an important role in hiding the truth about the assassination through his participation in the Warren Commission, which had only one task: To cover up all the facts of the assassination.

I also recommend my own investigation into the Kennedy assassination, *The Country That Killed Its Leader* - which was the result of six months of intense research, during which time I came into contact with many of America's foremost researchers on the Kennedy assassination. In my opinion, all the evidence suggests that Kennedy was first hit by a shot in the neck from one of the shooters at the picked fence on the grassy knoll, i.e. from the front, while the head shot, which definitely killed the president, was fired from the south knoll - the south end of the triple underpass, also from the front. Here I rely, among other things, on the now deceased, highly respected forensic scientist Sherry Fiester, who has analyzed Kennedy's head

injuries based on her extensive experience as a forensic expert.

Many Kennedy researchers believe the head shot came from “the grassy knoll” because the Zapruder film shows Kennedy first being thrown backwards and then falling to the left. But if the shot had come from the right side in front of Kennedy, in my opinion, he would have been thrown backwards and to the left at the same time. But that's not what happens. He is only thrown backwards by the shot, and this indicates that the shot came from the left side in front of Kennedy, i.e. from “the south knoll”, because at the time he was facing left after the shot in the neck. It was only after the body was lifeless that Kennedy fell to the left, due to his position in the car, in my opinion.

Considering the catastrophic polarization between the Democrats and Republicans of our time, one might almost wonder why neither Joe Biden nor Donald Trump were assassinated long ago. Perhaps it's because in 1963 the establishment had every means, including the American press, at its disposal to blame the murder on a lone, crazed gunman, as they did with the murders of John F. Kennedy, Robert Kennedy, Martin Luther King, Bob Marley, John Lennon, John F. Kennedy Jr. and probably many, many more. But today, it is obviously not so easy to assassinate a president of the United States and blame it on a single, crazy man - fortunately.

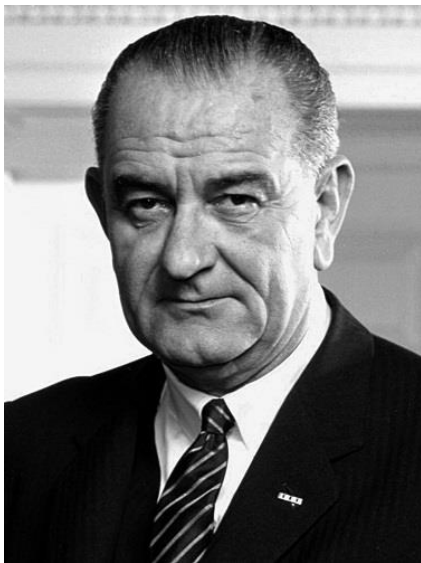

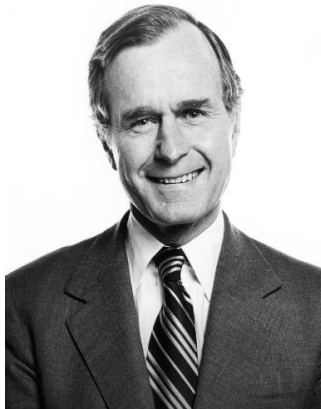

It is obvious that this cruel and tragic murder still engages people - almost 50 years after it took place. My very comprehensive political and technical analysis of the murder is not really intended specifically for supporters of Toward the Light! which my website is otherwise mostly about, but is written to hopefully help increase understanding of how a political murder of the man who held perhaps the world's most important (and most powerful) office could only take place as a result of an extensive conspiracy between some of the United States' strongest power groups, and how the same, powerful groups managed to cover up the conspiracy through one of the most brazen and successful cover-ups in world history, prepared by the so-called Warren Commission.

But a reader who knows TtL intimately will no doubt have had some thoughts about the fact that these powerful power groups in the USA, such as the CIA, the FBI, the mafia, the oil moguls, the powerful arms manufacturers, etc. must have attracted some of the spiritual personalities we know from TtL as “the Elders”; brilliant but evil personalities without conscience, who were incarnated as humans in order to bring disorder, evil and suffering to mankind, for these have always sought power, privilege and wealth, and spared no means to achieve their goals.

decades and centuries.

It is enough to look at the date of birth of the various people involved to determine whether or not they may have been one of the oldest. Let me just mention that the two powerful people with highly questionable personal morals, J. Edgar Hoover and Lyndon B. Johnson, were born in 1895 and 1908 respectively, well before the foremost intelligence of evil gave up the fight against the forces of light.

Probably the most powerful man in the USA for many decades was J. Edgar Hoover, head of the powerful FBI organization, which infiltrated every environment of significance and monitored everything that could crawl and walk in the USA and had a “ball grip” on the entire political power elite. Through outright threats and blackmail of JFK because of the latter's, to put it mildly, debauched sex life, Hoover had “his” man inaugurated as Vice President; Lyndon B. Johnson, known by those closest to him as an unscrupulous, cynical and brutal power seeker, who was built up politically through financial support from the arms industry, and with a very suspicious past with links to several political murders and criminal acts.

Together, these two remained the great victors after the assassination of John F. Kennedy; Hoover consolidated his power and eradicated a dangerous threat, and Johnson fulfilled his ambitious dreams of becoming the most powerful man on earth, President of the United States. Personally, I have no doubt that they were both of the oldest, and together they arranged one of the most brazen cover-ups in world history, when they managed to convince almost the entire world that the very far-sighted peace politician of genius, John F. Kennedy, had been murdered by a lone, half-mad fanatic. While the truth was that it was in fact a very well-directed coup d'état, where the entire political, economic and criminal power elite in the United States saw it in their interest to get rid of the visionary and charismatic statesman Kennedy, in order to replace him with one of their errand boys, who could ensure that their positions of power were not threatened and that they could continue undisturbed with their semi- and fully criminal activities.

Although many Americans do not consider the assassination to have been solved, and although many believe that Kennedy was murdered as a result of a conspiracy of some magnitude, it is unlikely that the average American is aware of how broad this conspiracy actually was, nor are they aware of how thoroughly corrupt and criminal their own leadership was for decades, and still is. Anyone who knows TtL will know how the struggle between the pioneers of light, the youngest, and the champions of darkness, the oldest, has taken place on earth for millennia, and where the light has put in great forces to bring humanity forward in peace, understanding and

civilization, there the darkness has also put in the greatest counter-forces.



It is reasonable to believe that the two Kennedy brothers, John Fitzgerald, 1917-1963, and Robert Francis, 1925-1968, were incarnated by God as a counterbalance to the dark forces that threatened the USA. The Kennedy family also had an older son, Joseph Patrick Kennedy Jr. 1915-1944. TtL also tells of how the forces of light apply the greatest forces where the opportunities to achieve the best results are greatest. Even though the United States is a young nation, it had its starting point in the very best values a society can have, and for the representatives of the Light, this young, noble and freedom-loving nation must have heralded very great and valuable progress for the Light on Earth. And in a marvelously short period of time, the country developed into a world leader and fostered ingenious inventors and innovators. All indications are that many of the youngest were incarnated in the USA, which alone can explain the remarkably short time it took from the country's founding until it had become one of the world's most prosperous and innovative. Of course, this also meant that the Elders were incarnated in large numbers to fight against the Youngest and seek power and influence for the ideas of darkness.

During the very unwise Prohibition era, powerful criminal syndicates were established, and as a result of US participation in World War II and the Cold War, the United States developed into a military superpower, where arms manufacturers could build up gigantic fortunes, and the intelligence community and the military were allowed to operate almost without control from the political leadership. It must be assumed that many of the elders found their way into

leading positions during this period, and were among those who built up enormous fortunes from oil extraction and the production of weapons of destruction, and secured leading positions in the military, CIA and FBI. As powerful states within the state, these organizations established their position during these years, and their power was so great that they could almost single-handedly steer US foreign policy.

Maintaining its power became an end in itself, and no stone was left unturned to ensure that no one and nothing could threaten the USA or its own position of power. The United States was slowly but surely becoming an empire ruled by the evil, power-hungry and unscrupulous elders, and the youngest seemed to be on the defensive. The USA had become the world's strongest power, and this power was abused to trample on and keep down all those considered to be the country's enemies, and internally to fight all dissenters and minority groups. The military, the CIA and the FBI were linked to military groups and assassins, and political opponents were exterminated and murdered all over the world, including within the USA.

It must have been a matter of great urgency for the extrasensory world to take countermeasures in order to regain control of the world's strongest power if possible, and I am personally convinced that large numbers of the youngest were incarnated in the USA at the beginning of the 20th century because it was possible to anticipate the attempts of the darkness to seize power through the etheric records the servant of darkness had designed before his conversion. He had the ability to make very detailed and evil plans for the fate of individuals and entire nations, and to store these evil plans in the ether, so that they send a stream of darkness over people and inspire us to think certain predetermined thoughts and act according to certain preconceived plans.

Not only are humans exposed to the darkness and evil that surrounds us on earth, we are also exposed to a "bombardment" of thought impulses from complex images of the future that are stored in the ether that surrounds the earth.

The thought impulses that can affect the individual are thus part of large, complex plans aimed at leading humanity into war, suffering and death! I

would assume that God incarnated one of the spirits of light as John F. Kennedy, and several of his brothers were probably among the youngest - at least his brother Robert. It was certainly not difficult to predict that the very ambitious and powerful father, Joseph Kennedy, would manage to get one of his sons inaugurated as President of the United States, and the spirits of light often (but not always) choose to incarnate where they can most easily accomplish their desired mission. In order for the light not to completely lose the battle against darkness in the world's most powerful nation, it was dependent on the youngest being able to deprive the powerful criminal groups of their power, and both the CIA and the FBI posed dangerous threats to the USA's position as a freedom-fighting country, and hatred of the former noble nation was awakened in large parts of the world, where they waltzed unscrupulously forward with brutality and oppression.

The homeland of freedom, with equal rights and duties for all free citizens, was being transformed into a country where the strongest had the right to brutally oppress and exploit the weak.



John and Jackie Kennedy were probably the closest the US has ever come to having a royal couple. They were young, beautiful and charismatic, and were both very popular with many Americans. It was a terrible shock to the whole world when Kennedy was shot and killed. So John F. Kennedy was most likely one of the youngest, who was incarnated as a representative of the light, to win the USA back to the light! And everything went quite well according to plan until he was elected the 35th President of the United States, an event that must have aroused enormous joy and high hopes in the supernatural world. And I would like to think that JFK acted very well in accordance with his convictions in the major issues that faced him as president! He was very popular, charismatic and visionary, and managed to ignite a hope of peaceful coexistence for an entire world.

Through his eloquent and persuasive speeches, he expressed the hopes of a whole world for the future! And he showed in a wide range of cases that he was worthy of trust. He supported underprivileged and oppressed groups, was a compassionate and warm social politician, and in 1961, when the world was on the brink of collapse in the conflict between the USA and the Soviet Union over the deployment of Soviet nuclear missiles in Cuba, he showed statesmanship that saved the world from a devastating nuclear war.

But while Kennedy inspired hope for the future in many people, he was also intensely hated by those who saw themselves threatened by his policies. This was particularly true of all those who had established power groups that benefited from privileges and evaded political control and obligations to the country's laws and public goods. And besides, Kennedy had his own demons to contend with, and probably both etheric records and his own past unsettled karma to face in his earthly life as John F. Kennedy. By giving in to destructive thought impulses, he too would draw the darkness around him, making his work as a brilliant statesman and one of the foremost representatives of light on earth more difficult. It is not difficult to assume that it was in the sexual sphere that the darkness launched its foremost attack against Kennedy, as it has done against so many of the youngest, but the darkness in no way succeeded in making Kennedy unfit to carry out his work. But in all likelihood one or more evil etheric records stood against him, and the more Kennedy acted against his conscience, the more nourishment he naturally gave to the power of the etheric record, and the stronger the etheric record could act on the people who opposed Kennedy!

But why couldn't God have protected Kennedy from the assassination plans if it is true that his role as one of the foremost champions of light on earth was so important? I am convinced that God, through Kennedy's guardian spirit and the other discarnate younger ones, did everything in their power to protect the president, both by strengthening him personally and warning him when he was about to make a mistake, and also by trying to prevent others from following the evil thought impulses of the etheric record rather than their conscience.

But when it comes to the elders, all such attempts to strengthen their conscience are futile: They have no conscience, and lack empathy and compassion for others. When such black geniuses came under the control of the etheric records, they were therefore exposed to a double attack of darkness, both the darkness that permeated their personality and the darkness with which the etheric images lined their consciousness. And in my opinion, a whole clutch of elders were probably involved in the murder plans, because within all the groups I have mentioned, you will find people born before 1912 - people who bear all the hallmarks of being among the elders: Power-hungry, ambitious, unscrupulous and brutal!

The United States was probably the country in modern history where the struggle between the ever-incarnate elders and the youngest was fought in its most acute form, both because of the

country's very important role in the world community and because it never fell completely into the power of the elders, such as Germany, the Soviet Union, Italy and others. In the United States, darkness and light fought a more equal battle, and despite the fact that today's United States is still ruled by ruthless economic groups and a thoroughly corrupt political system, the human urge for freedom is so strong that the country provides a very favorable breeding ground for free will to unfold unhindered, which is a prerequisite for any human progress.

In order to understand why the Youngest failed to prevent Kennedy's assassination, it is also important to consider human free will! God and the Youngest can do much to strengthen the individual's will and ability to resist the darkness, but if the individual of his or her own free will chooses to act according to the thought impulses of the darkness, the Youngest can do nothing, for God forces no one to follow His will. If Kennedy acted in such a way as to strengthen the power of the etheric record, it could thus ultimately be impossible for the youngest to prevent its entry into the world, no matter how much they wished it, for God always respects the free will of mankind.

It was therefore very important for the forces of darkness to try to subjugate the United States in order to prevent human progress and to maintain their world domination. To inspire a conspiracy between the forces of darkness to assassinate the Youngest(s) incarnated to bring the United States under the control of the Light would, of course, be a gigantic victory for darkness. Not only because the work of the youngest was directly prevented by their removal as human beings, but also by the grief, discouragement and sadness that an assassination of a president who represented the people's hopes for the future and their dreams of a better world would trigger. For the elders, it would be a great victory if the forces of good were to lose faith that it would ever be possible to transform the earth into a place where people can live in peace and love. But the more the victim thinks and acts in accordance with the etheric record's "instructions", the greater the power of the etheric record over them, and in the end they actually act as will-less robots, despite being convinced that they are following their own will.

The seemingly strange thing about the plans to assassinate JFK was that they arose almost simultaneously in several circles, without these having any contact with each other, and without any of them following a common overall plan. They didn't need to; the plan already existed, as an ether image created by the foremost servant of evil. This is why many of those researching the Kennedy assassination have been convinced that they have found the origin of the plans to assassinate Kennedy in one particular environment, while the truth is that the plans originated around the same time in several environments, and the plans developed as if they were all following a common plan, and only at a later stage did it become clear to the various groups that they all had a common interest in getting the American president out of the way in order to secure their own position of power and their own company's continued unhindered activity.

Oil billionaires no longer had to worry about huge revenue losses as a result of a change in tax policy, arms manufacturers secured their billiard revenues by installing a war-friendly errand boy, and the mafia escaped the incessant disruption of its criminal activities by the president's brother, Attorney General Robert Kennedy, The CIA no longer had to fear its own disintegration, the Cuban exiles finally had an outlet for their rage at the failed attempt to overthrow the communist regime of Fidel Castro and the FBI could continue undisturbed with its corrupt blackmail and intimidation activities to control American politics! The Mafia contributed with its very long experience of getting the murder nailed to a patsy, the CIA contributed with its huge apparatus to build up a credible scapegoat, the billionaires arranged the financing, and the FBI and the Vice President took responsibility for deceiving the nation into believing that a lone, half-mad communist sympathizer was behind the murder.

In reality, Lee Harvey Oswald was an informant for the CIA and FBI, and his stay in the Soviet Union, his renunciation of his American citizenship and his membership of a Cuba-sympathizing organization were arranged by the CIA to create a credible patsy, while Oswald himself thought he was a valuable informant! The whole thing was so cunning, brazen and cruel in all its evil, that the nation of the United States in its naivety apparently accepted the explanation. It takes a certain amount of courage to realize that your country's president has been murdered by the country's own political leaders in collaboration with the country's most unscrupulous, brutal and vicious criminals, and many still refuse to face it! 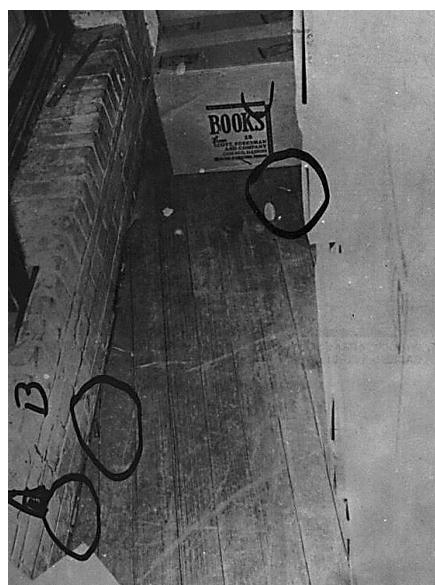
Congressional Commission 1979: More shooters.

As early as 1979, a congressional commission determined that more than the officially accepted three shots must have been fired at the president, thus destroying the entire basis for the presidentially appointed Warren Commission's 1964 conclusion, which identified Lee Harvey Oswald, the man with the most remarkable ties to the Soviet Union and Cuba, as the lone assassin.

The designated lone shooter could not possibly have fired.

The 'murderer' had chosen perhaps by far the worst 'murder weapon' available, namely an Italian-made Mannlicher-Carcano rifle, manufactured before the Second World War. This weapon is extremely slow to operate.

Repeated trials under controlled conditions have shown that it is simply physically impossible to fire as many as three shots with a Carcano rifle during the six seconds or so that the series of shots lasted, according to the official version of events. Nevertheless, the Warren Commission's version was accepted by the public. Ballistic tests also showed that the sights were completely misaligned, and it was not even possible to prove that the rifle had been fired on the same day! Lee Harvey Oswald, who four weeks earlier had started working at The Texas School Book Depository, where shots were fired from the 6th floor, is shown in several stills standing in the exit of the school book depository.



To be 100% sure of being revealed, the 'murderer' had left a rifle and three empty shells in the snipers' nest. Unlikely easy to 'solve' the murder.

The weapon was linked to Oswald through a fake ID card issued in the name of Alek James Hidell, found in Oswald's possession after his arrest, surprisingly soon after the assassination, and the weapon was bought by mail order in this name. This seems surprisingly amateurish, given that Oswald could have walked into any gun shop and bought a state-of-the-art high-speed rifle without having to reveal his identity, thus leaving no trace linking him to the murder. And it would be the easiest thing in the world to plant a fake ID card among his belongings.

In addition, it seems incredibly clumsy to leave both the 'murder weapon' with fingerprints and three empty shells at the murder site. Either Lee Harvey Oswald must have been one of the stupidest snipers in the history of the world, or he must have done everything possible to get caught for the murder. Didn't anyone react to the fact that the whole thing was simply too obvious? Incidentally, there has been some confusion about what kind of weapon was actually found, because the first reports were that it was a German-made Mauser. However, this is probably due to the fact that those who found the weapon were unable to identify it reliably and thought it might be a Mauser. It later turned out to be an Italian-made Mannlicher-Carcano rifle.

Oswald's wanted poster, with a full description, was also broadcast unusually quickly on the police radio, and no-one was subsequently able to give a credible account of why he was wanted at all. The explanation that was eventually presented was that he did not return to the school book depository after leaving it shortly after the murder. But that applied to up to 30 other employees at the warehouse, and none of the others were wanted.



The plan, of course, was for Oswald to be shot and killed for resisting arrest, but something went wrong during the arrest. Mafia man and nightclub owner Jack Ruby, who was responsible for organising the shooting teams and coordinating the events, therefore had to single-handedly execute Lee Harvey Oswald on live TV. Jack Ruby later went to great lengths to reveal that Lyndon Baines Johnson was ultimately responsible for the assassination of US President John Fitzgerald Kennedy. It was in fact a coup d'état, with the complicity of the Secret Service, the CIA, the FBI, the oil moguls, the arms industry and the industrial billionaires. Even the US Congress recognised in 1979 that Kennedy was assassinated as a result of a conspiracy but chose not to continue the investigation. They probably feared what would be revealed about their own people.

The ‘scapegoat’ was removed before he could explain himself.

So Lee Harvey Oswald left the school book depository after the assassination, made a quick stop at his dormitory and then went to a cinema, where he was arrested by the police. It's almost as if the police already knew where to find Oswald! Along the way, he is also said to have murdered a policeman, who is said to have surprised him. Within a very short time, the police had arrested the ‘killer’, and the evidence against him was apparently so clear and obvious that he was quickly identified as the lone assassin who had shot the president with three shots from behind, fired from The Texas School Book Depository!

And if that wasn't enough, Oswald himself was shot and killed by Mafia-linked nightclub owner Jack Ruby while in police custody and being transported from prison, so he never had a chance to explain himself properly.

Mafia member Jack Ruby had to clean up the mess.

Ruby's motive for killing Oswald was that he found it so emotionally upsetting that Oswald had killed the President that he felt he had to personally punish him for the misdeed. How on earth could anyone believe such an unlikely story as a Mafia member killing the President's murderer because he was emotionally upset by the crime? Isn't it fairly obvious that Oswald was killed to be silenced? Most of the evidence suggests that Oswald was a CIA-employed infiltrator in the Cuban exile community, and that he was convinced that he would be transported safely out of the USA after the assassination, and sent to Cuba, for which he had already obtained a visa in the autumn of 1963.

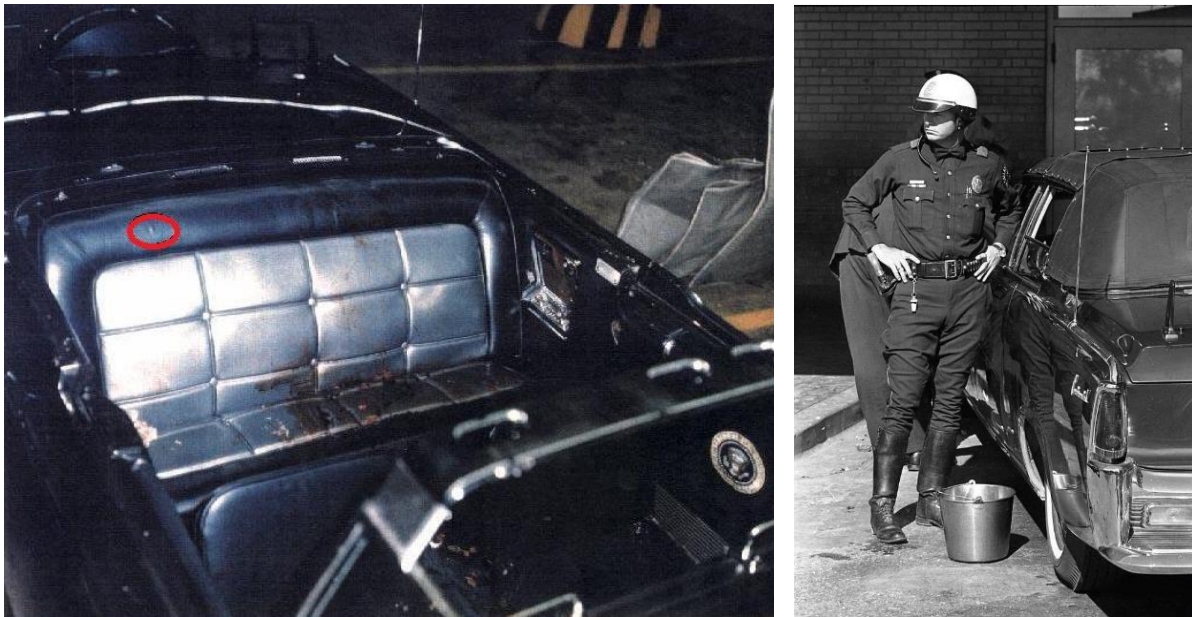
But in reality, he had been built up over a long period of time to act as ‘patsy’, the scapegoat to be identified as the lone killer. A very common method in the American mafia world! He was probably supposed to be murdered before or during his arrest, but something went wrong and Jack Ruby had to clean up the mess.

Inadequate investigation.

But most Americans have never settled for the official explanation, and since the assassination countless books and serious investigations have been published, the internet is almost overflowing with discussion forums and websites, and there are people who have made it their life's work to reveal the truth about the assassination. In my own studies of the assassination, I have been in contact with several of these serious Kennedy researchers, who comprise a professionally very diverse group, from forensic scientists to professors.

What is revealed when one takes a serious look at the presidential assassination with an open and unprejudiced mind is an exceptionally flawed investigation, blatant failure to investigate clues that contradicted the official theory, blatant failure to call witnesses who had made anomalous observations, systematic confiscation of all film and photographs from the assassination and blatant falsifications of images and film material that were returned.

The Secret Service seized the body.



Both the Elm Street road and the presidential limousine were the scene of a criminal act and should have been immediately cordoned off and made available for investigators to search the scene for any possible clues. But Elm Street was never cordoned off, and random bystanders were free to walk around looking for gunshot wounds on the road and lawn and picking up remnants of Kennedy's brain matter and skull. A few photographers managed to photograph the back seat of the car, which was also full of blood and remains of the president's head injury. The images also reveal a bullet hole where the president had been sitting - obviously from the shot that hit Kennedy in the throat. But the Secret Service and the police quickly put the roof on the car, and then the car was thoroughly cleaned. A highly irregular event. To the right is a police officer with a bucket of water. Reliable witnesses report shots from several different directions at Kennedy, and the number of shots reported varies from three to six! Secret Service agents virtually seized the body after Kennedy was first rushed to the nearest hospital, Parkland Hospital, where the autopsy was to take place under US law. But after a few futile attempts at resuscitation, Kennedy was pronounced dead and the body was transported to Bethesda Naval Hospital, where the autopsy was performed under the full control of the Secret Service by a doctor who had never performed an autopsy before. And the injuries to Kennedy reported by the doctors at Parkland differed markedly from the autopsy report.

Big difference between the first doctors' observations and the autopsy report.

According to several Parkland doctors, Kennedy had an entrance wound in his neck and a fist-sized exit wound on the right side of the back of his head. According to the official autopsy, the small wound in the neck was an exit wound, and the wound in the back of the head did not exist. However, a wound on the right side of the head did. According to the official story, Kennedy was shot from behind, but according to up to 50 witnesses, shots were also fired from the front. According to several of the spectators, as well as police officers in an escort car and on a motorbike, Kennedy was shot from the front, leaving a shower of blood, brain

matter and bone splinters behind!

Among serious Kennedy researchers, three to five sniper positions are often assumed, and that shots were fired from both the front and the back, so that Kennedy was in fact under crossfire! And there is a high probability that both of the two shots that hit him came from the front, from a fence on 'the grassy knoll', a grassy slope down towards Elm Street, and from 'the triple underpass', a railway crossing opposite Elm Street, where three roads cross under the railway tracks.

The murder remains unsolved.

The deficiencies in the investigation of the Kennedy assassination are so obvious, and the witness observations so contradictory, that it's a wonder the case hasn't been reopened long ago! The average American is probably overdue to know the truth. The unsolved murder is lying there like a sore thumb and does not give most Americans any peace. But is the nation's 'self-image' able to withstand the dark secrets that will eventually be revealed? Most serious Kennedy researchers agree that the assassination was the result of a conspiracy.

The only question is how broad the conspiracy was. Those who specialise in interpreting Mafia methods believe that the Italian Carcano rifle was planted to say that the assassination was carried out by the Italian Mafia because the Kennedy clan was systematically trying to destroy them. But most people also agree that the assassination would hardly have been possible, and the cover-up would definitely not have succeeded, without the support of employees of the CIA, FBI, Secret Service, Dallas police and other government officials.

In reality, a coup d'état?

Some go so far as to claim that the conspiracy was so extensive that it also included some of the most prominent American oil millionaires, who had an awful lot to lose from Kennedy's tax policy, wealthy arms manufacturers who feared gigantic revenue losses as a result of Kennedy's peace policy, and the Cuban exile community is also frequently mentioned, after the failed Bay of Pigs invasion, for which they blamed Kennedy. Some even regard the assassination as an outright coup d'état, in which strong and unscrupulous power groups in American society saw it in their favour to get rid of the president and replace him with their vice president, including the vice president himself! The co-operation between the CIA and the mafia was already established through the plans to overthrow Fidel Castro, and those who knew Lyndon B. Johnson were well aware of his unscrupulous quest for power! His inauguration as president would, in one fell swoop, resolve all the fears of the power groups involved about the consequences of Kennedy's policies! But are Americans ready to face the fact that their trusted government officials collaborated with the country's most unscrupulous and ruthless criminals and murderers to assassinate one of the most popular American presidents ever?

The Kennedy anniversary, a lousy advert for the journalistic profession.

For someone who is familiar with the enormous documentation on the Kennedy assassination, it has been very disheartening to follow the coverage in the media 50 years later. Have the journalists done any independent investigations at all?

Kennedy was one of the greatest heroes of my childhood. And when he was assassinated in the middle of my father's birthday celebrations on 22 November 1963, I encountered tragedy and grief for the first time in my young life. In all the years that followed, my father's birthday became a day of mourning in my family.

A couple of years ago, I set out to really delve into the evidence following the murder, in order to make up my mind once and for all about the truth of the murder. Fortunately, most of the testimonies are available online, and if you have the patience, you can familiarise yourself with pretty much everything the various witnesses observed. The commission. There is also an enormous number of books and articles, and the amount of information is simply gigantic. My starting point was that I didn't want to rely on any second-hand information, but to check all claims against the sources to see if they could be documented.

My work went on for about 6 months, and ended up in a large scale article published on the internet: **'The country that killed its leader - the assassination of John F. Kennedy'**. As far as I know, it is the most comprehensive analysis available in Norwegian. I have analysed both the political background and the assassination itself, and was fortunate enough to be able to initiate a collaboration with an American who had been interested in the Kennedy assassination and mafia violence in general all his life.

William Orchard has produced by far the best analysis of the shooting scenario that I know of, and his theories are based entirely on documented witness statements. Orchard has contacts in the most recognised research community in the USA, which includes highly

educated and serious people, who base their theories on reliable sources and not loose speculation. He took several photos for me in Dealey Plaza, which I use in my article. Among other things, he took pictures from the famous pedestal where Abraham Zapruder stood when he took his very famous film of the murder.

It was with this background that I followed the media's coverage of the Kennedy assassination 50 years after the tragic event. And I cannot characterise it as anything other than a very frustrating experience to see how pure lies from the past were reproduced as if they were provable truths. The few objections that were raised largely consisted of reproducing a number of conspiracy theories without taking a position on their content. On the whole, very few journalists appeared to have carried out independent investigations of

witness statements and evidence. Only second- and third-hand unsubstantiated claims were reported. Even television reports that purported to contain in-depth analyses mostly omitted to address witness statements or evidence that clearly contradicted their analysis. Several programmes interviewed some of the surviving witnesses, and today these are old and have obvious memory distortions or have been influenced by later theories, or they outright lie. A good example was the interview with the man Lee Harvey Oswald drove to and from work every day. Today, he states that a roll call of employees was taken immediately after the assassination and when it was realised that Oswald was the only one missing, he was put on the wanted list. In his testimony to the Warren Commission, he said several times that no one asked for Oswald at all after the murder, and he says nothing about a roll call. On the other hand, he says that employees were asked to go home about half an hour after the murder, and nothing indicates that anyone was missing. According to other sources, there were a large number of workers who did not return. But only Oswald was wanted.

I have yet to see a documented explanation as to why Lee Harvey Oswald was wanted just minutes after the murder. It is quite astonishing to hear recordings of radio reports that went out shortly after the murder. In reality, the murder was 'solved' without any investigation or witness statements. This should be very disturbing to all truth-seeking people.

It was established that President Kennedy had been shot three times from behind, fired from The Texas School Book Depository, and they even knew who the killer was. It must surely be one of the fastest murder investigations in world history. In the first few days after the murder, some newspapers dared to print witness statements that contradicted the official explanation, but then the consensus spread and became unanimous. One can't help but wonder whether the murder hadn't been 'solved' and the killer identified long before it was committed. Most indications are that Lee Harvey Oswald did not fire a single shot, but was a pre-selected 'patsy'.

And the evidence that Kennedy was shot from the school book depository seemed to be indisputable. The killer had left behind his rifle and three empty shells. Was more needed to prove that the shots had been fired from the sixth floor of the school book depository, and that only three shots had been fired? It is simply incredible that this was accepted as the truth. At least 40 witnesses testified to shots being fired from several directions, and after the shooting drama, many spectators and policemen rushed up to the grassy knoll because they had heard shots from there and smelled gunpowder smoke. These witnesses were completely ignored by the Warren Commission, and it cannot be characterised as anything other than remarkable that they failed to follow up these leads. It would be as if 40 of the surviving young people on Utøya could describe a second perpetrator, but the police chose to ignore their testimony. In this day and age, it would have been nothing less than an unprecedented scandal if the police had failed to investigate reliable testimonies that could possibly identify a second perpetrator.

Could Oswald then be linked with certainty to the crime scene? His fingerprints were found on some of the cardboard boxes in the snipers' nest. But so were the fingerprints of many of the other employees, and it can hardly be considered proof that Oswald had handled the cardboard boxes, as it was his job to pack books in cardboard boxes. Later it was claimed that Oswald's fingerprints were found on the Italian-made Mannlicher Carcano rifle, but this



Two people who played a role that many Kennedy researchers have questioned. Wesley Buell Frazier obviously played a crucial role in setting up Oswald as the lone assassin. Buell Frazier also worked in the schoolbook depository and offered to give Oswald a lift to work. It was Buell Frazier who planted the lie that Oswald had brought a weapon to the textbook warehouse, disguised as curtain rods. Contrary to what he told the Warren Commission, he also said afterwards that everyone returned to the textbook warehouse after the assassination except Oswald, and that he was therefore wanted. The first official explanation was that there were no fingerprints on the rifle, but then it was apparently 'found' anyway. On the other hand, it was reported that Oswald had bought the Carcano rifle by mail order in the name of Hidell. But this is highly dubious evidence. Anyone could have done this. Why didn't Oswald just walk into any gun shop and buy a rifle without having to identify himself?

No, instead he is said to have bought a rifle that could easily be traced back to him, and then left it at the murder scene. One is tempted to ask: How stupid can you get? Most murderers try to cover their tracks. Oswald apparently did the opposite. He planted evidence against himself at the crime scene, as if to ensure that he would be caught. Beyond this, there was no evidence pointing to Oswald. A few witnesses were able to describe a shooter on the sixth floor of the school book depository, but these testimonies diverge in all directions, and the only description that resembled Oswald was considered so dubious that even the police did not trust it.

Over the past few years, several amateur films have been released showing a man with a strong resemblance to Oswald standing in the exit of the school book depository drinking a Coke shortly after the assassination. One film shows the same man walking down from the stairs to the school book depository and onto the road ahead. The film also shows a man with a strong resemblance to Jack Ruby. Witnesses say that they saw Oswald and Ruby together outside the school book depository, and that Ruby handed Oswald a revolver. Probably the defective revolver Oswald was arrested with.

Subsequently, amateur films have also been uncovered that show a person who looks very much like Oswald standing in the doorway of the school book depository. This man is known in the research community as 'the doorman', and those who have analysed the well-known photo of James Atkins, where you can see the people standing in the doorway through the window of the presidential car, are very sure that one of them is Lee Harvey Oswald, who has been retouched to try to make it look like a different person. This is consistent with Oswald's own testimony; he claimed to be standing in the doorway with a number of employees in the school book warehouse.

The 'proof' that Oswald brought a rifle to work that day is as flimsy as the claim that he was on the 6th floor. His work colleague said that Oswald had a parcel about 60 cm long with him in the car when they drove to work together that day.

Counting this as proof that Oswald had bought the Carcano rifle cannot be called anything other than speculative. In response to a question from his colleague, Oswald said that he had brought curtain rods. The colleague replied that he remembered that Oswald had told him the day before that he was going to organise something with curtain rods. It is simply unbelievable that the police did not make greater demands on the evidence, and in later documentary films you often see Oswald in this scene carrying a long package, as long as a rifle. In reality, it was about 60 cm long.

When Lee Harvey Oswald was murdered, he also lost one of his most fundamental rights; he was never allowed to defend himself against the murder charges. He was proclaimed for all the world to be a presidential assassin. I am convinced that if a trial were held today, in which Oswald was given the very best defence the US can give him, he would have been acquitted. The evidence is razor thin, all other leads were ignored and the investigation was so sloppy and unsystematic that it can only be called a disgrace to the American justice system.

And the most frightening thing, in my opinion, is the journalists' fairly consistent lack of independence in their assessment of the murder. Unfortunately, over the years, many, perhaps in their desire to reproduce the official explanation so that it seems reliable, have embellished the story here and there and gradually explanations have emerged that are far from the truth, and which cannot be found in the witness statements. And when the journalists do nothing more than reproduce the official story, they repeatedly condemn a completely defenceless man as a presidential assassin. I call it, with very good reason, the most shameful miscarriage of justice of the last century.

Who fired the fatal head shot that shattered President Kennedy's head?

I hope the reader has found the new information that has emerged in the Kennedy research interesting and credible. But the biggest question remains: Who fired the fatal shot that shattered Kennedy's head? And do we have enough information now to be able to pinpoint specific shooters?

Firstly, let me say that I have long had an idea about who fired the shot. And my assumption is based on several fairly certain indications. The first thing that led me to my assumption was the many pictures taken in Dealey Plaza of the so-called 'three tramps', who were under arrest and being led by a police officer for the benefit of a large number of photographers and onlookers. They were on their way to be questioned at the Dallas police station. For many years, there was no trace of the arrest in a single report or interrogation document, but in 1992 an arrest report appeared, and named men later stated that they were the ones arrested and that they had spent the night in a local hospice and were therefore so diligent and clean-shaven as to be homeless.

But was it them? The fact is that the people pictured are almost identical to well-known criminals and assassins, and one of them has also admitted that he was at the railway crossing in several interviews. So what are we to believe? The Kennedy assassination is full of forgeries and people who lie, so it's almost impossible to reveal what the truth is.



There are many photographs of the so-called 'three tramps' who were led by a policeman a long way to get to the police station, and these men have naturally aroused the interest of Kennedy researchers. For a long time, nothing was known about who they were or what they were doing in Dallas from the police archives. Many people have tried to identify them, and in fact they bear quite a strong resemblance to people we recognise from the criminal underworld in the US. Photo from the internet.

Before I continue with the identification of the three men, I would like to recapitulate a little from my first thesis on the Kennedy assassination from 2011: 'The country that killed its leader - the assassination of John F Kennedy'. In it, I discuss quite extensively from which direction the head shot must have come. Many believe that the person who fired the shot must have been on 'the grassy knoll' (GKF), by 'the picked fence' - i.e. on the grassy knoll to the left of Elm Street as seen from the front. The shot must therefore have come at an angle from the front, from the left of the car, seen from the front.

After studying Kennedy's position in the limousine and the injuries to Kennedy's head after the shot, I have come to a different conclusion. Namely that the shooter must have been on the other side of Elms Street, i.e. on the south knoll by the railroad overpass (RROP). Many of those who believe that the shot must have come from the left, base this on the fact that Kennedy fell to his left side after being hit. In other words, it is believed that the direction from which the shot came caused him to fall to that side.

But when you study how Kennedy was sitting in the car, you see that he was cramped up against the car door, and when he was hit and his body became lifeless, it only had one direction to fall in, namely down into the car seat. We know that Kennedy was wearing a tight corset due to his back injury, so he could not fall forwards.

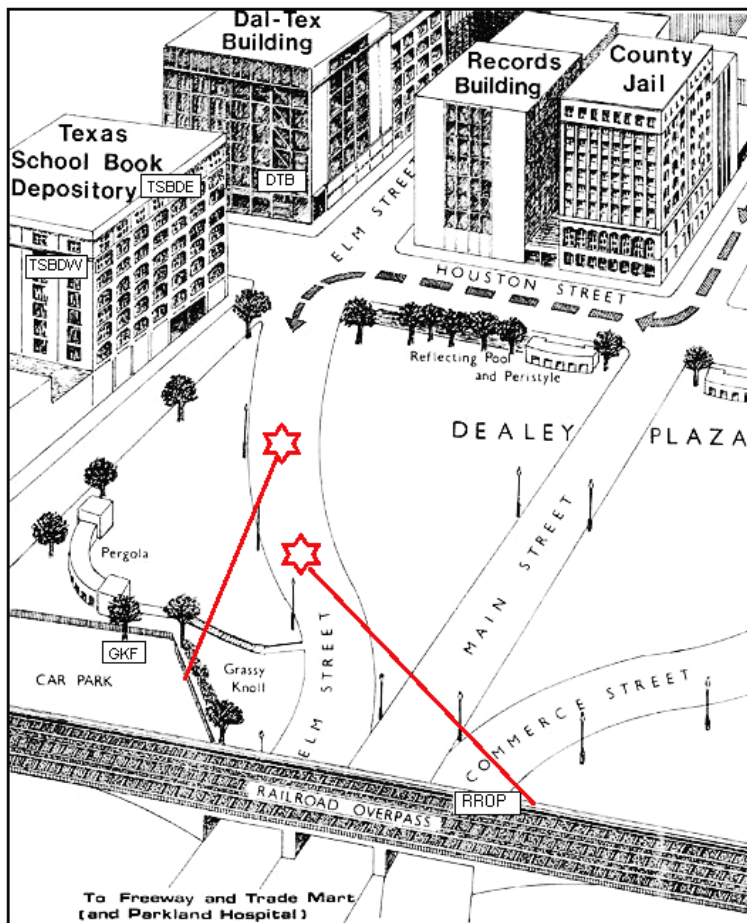
Another factor in favour of the shot coming from RROP is that Kennedy's head was turned to the left side when the shot was fired, and if the shot had come from GKF, Kennedy would have been hit on the right side of his head, creating a large exit wound in the back of Kennedy's left head. But that's not where he had a fist-sized exit wound - the wound was on the right side of the back of his head.



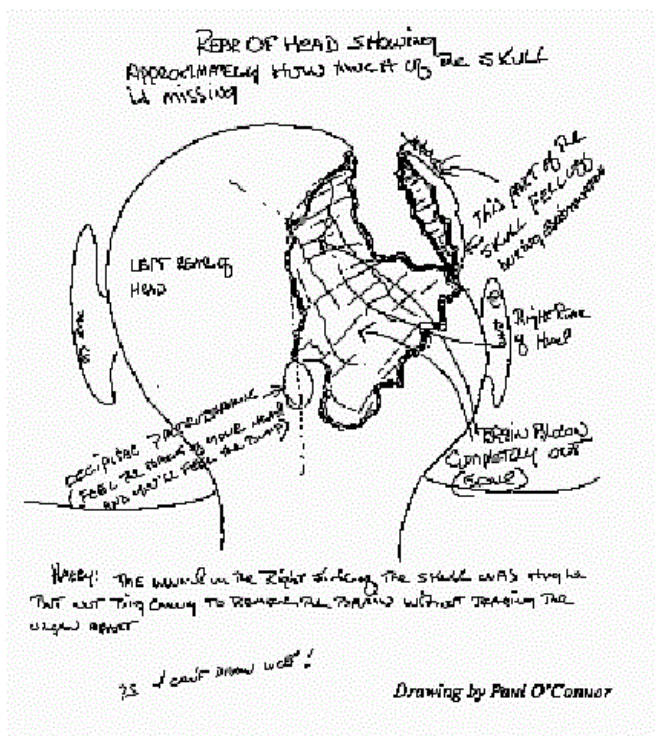
This was Kennedy's position in the car. His legs were pushed to the side because there was little room behind the front seat. When the body became lifeless, I believe gravity would pull the upper body to the left and down into the seat towards Jacqueline. Photo from the internet.



This is the last frame of the Zapruder film before Kennedy is hit in the head (z 312). We can see that his head is turned to the left and bent forwards. The shot must have come from the left of Kennedy and from the front, for the exit wound to be a large crater on the right side of the back of Kennedy's head.



This is how I believe the shots hit Kennedy. The shot that hit him in the throat came from the right of Kennedy and from the front, from GFK, went through the body and made an exit wound in the upper back and a bullet mark in the seat behind Kennedy. The shot that killed Kennedy, and almost crushed Kennedy's head, must have come from the left of Kennedy and from the front, from RROP. The shot struck Kennedy on the right side of the forehead, leaving a fist-sized exit wound on the right side of the back of Kennedy's head. The shooter probably used an expanding bullet to maximise the damage.



The Secret Service did not allow Kennedy's autopsy to take place at Parkland with neutral doctors. They seized the body and had it transported to Bethesda Military Hospital. Bethesda Marine Corpsman Paul O'Connor opened the grey crash bag and lifted the president's body out of the pinkish-grey shipping crate. He made this drawing of Kennedy's head injury, as he saw it with his own eyes. You can clearly see the enormity of the damage, with part of the skull just hanging on to the scalp like a hinge. This damage is also clearly visible in the Zapruder film. Parts of the skull, blood and brain matter splashed out into the road and onto the motorcyclists riding behind the limousine. Parts of the head were also left in the back seat. In a fit of acute confusion, Jacqueline crawled to the back of the car because she saw a piece of her husband's skull and she wanted to retrieve it so it could be reattached.

I'm not the only one who has concluded that the shot that hit Kennedy in the head must have come from the RROP. So has William Orchard, an American Kennedy researcher who has delivered a very intelligent analysis of all the shots against Kennedy, both from behind, from the front and from the side. And not least the American forensic scientist Sherry Fiester, who has published a book on the Kennedy assassination. I rely on both of these two.

But why has it been so important to establish the fact that the head shot must have come from the right, from the viewer's perspective? I can answer that it is related to what has emerged in Roderick MacKenzie III's book about the attack. In his book, there is a coincidence between the identification of 'the three tramps' and what Johnson's hitman Malcolm 'Mac' Wallace said about who the shooting team at RROP consisted of. Because it turned out, after MacKenzie's book became public knowledge, that the three people identified as the three tramps were the same men Wallace had said were stationed at RROP. And maybe that can't be a coincidence?

Malcolm Wallace told Roderick MacKenzie III that the shooting team at RROP consisted of [Charles Rogers](#), [Charles Harrelson](#) and [Chauncey Holt](#). And 'coincidence' would have it that the men referred to as 'the three tramps' are confusingly identical to those whom MacKenzie lists as the shooters at RROP. Now it must be added that MacKenzie states that this shooting team was not used, but this information should probably be seen in light of the fact that Malcolm Wallace was very drunk when he told about 'the hit parade', and MacKenzie regularly had to go to the toilet to write down the information on toilet paper, so he would not forget anything. It's quite likely that some of the details went wrong.

Of the three men, only Chauncey Holt has spoken out about the incident, and he has confirmed that he is one of the three men photographed in Dealey Plaza. He was a known

criminal with ties to both the CIA and the Mafia, and was involved in planning the failed US invasion of the Bay of Pigs in Cuba to overthrow Fidel Castro. Holt has also admitted that he was present at the railway crossing when the shots fell, but claims to have been framed. Both the other two, Charles Harrelson and Charles Rogers are known as very brutal assassins, and Harrelson in particular was notorious for his total insensitivity towards people who suffered under his brutal torture. It is also said that he killed his own parents because they interfered with his business.

I must admit that the identification of 'the tall tramp' as Charles Harrelson is the only one that has given me a hint of doubt. However, there are so many similarities that I have concluded that there is a very high probability that it really was Charles Harrelson who was photographed shortly after the assassination. Harrelson is known as an assassin, and in an interview he boasted that he shot the president. Photos from the internet.

Having now gone through the identification of these three men, I have to admit again that in 1992 an arrest report was published from the Dallas police archives, which contains information about an arrest at the Dallas police station made at 16.00, 22.1163 and it was stated that three men were arrested at the railway station and the three are identified as Gus Abrams, Harold Doyle, and John Gedney, and two of them appeared in the media and confirmed that they were the men who were arrested in a railway carriage and taken to the Dallas police station. There, according to [the police report](#), they were held for four days before being released. To explain why they were clean-shaven and well-groomed, they said they had spent the night in a homeless shelter and had been given a bath, a shave and new clothes.

What are we to believe? Are the coincidences of reality so unbelievable that three hobos were arrested on the same day that three members of one of the shooting teams were in Dealey Plaza, and they are identical? It's almost TOO unlikely, and what seems unlikely is often exactly that. What speaks in favour of the police's story, which was confirmed only in 1992, probably being false, is that forgers would have no problem whatsoever in retrospect creating a police report dated 1963, which looks absolutely genuine. The CIA, the FBI and the mafia are well known for their ability to cover their tracks and falsify the real events. And bribing or threatening someone to play along with a lying story is something the mafia specialises in. Countless people have felt compelled to take part in lies under the threat that they or their family would be murdered if they refused. But as a Kennedy researcher, I must at least point out that this information about 'the three tramps' exists, and that it contradicts the theory that it was one of the shooting teams that was arrested. What one believes must be up to the individual, but personally I am 99% sure that the three persons pictured are Charles Rogers, Charles Richardson and Chauncey Holt.

Well, regardless of whether or not the photographs of the 'three tramps' show the shooting team at the RROP, Roderick MacKenzie III has identified the three shooters at the south knoll

as Charles Rogers, Charles Harrelson and Chauncey Holt. Of these, Harrelson has boasted of killing a president, while Holt has claimed that he did not take part in the conspiracy, but was present. All three are dead today, and Charles Rogers has never been interviewed about the assassination because he was transported in a CIA plane to South America where he eventually disappeared. According to MacKenzie, Rogers was an exceptionally brutal and ruthless man, who taught South American torturers how to torture.

When you combine my opinion of where the head shot must have come from, namely 'the south knoll', with Roderick MacKenzie's information about which shooters were deployed there, I draw the conclusion that one of those MacKenzie has named must be the one who fired the fatal head shot that ended Kennedy's life in the most brutal way. I don't think Holt can be this shooter - he doesn't seem brutal enough to have fired a shot he must have known would crush the president's head.

For me, it's between Charles Rogers and Charles Harrelson. And from what I've read about the two of them, I'd like to favour the former. That assumption is strengthened by the fact that he was sent by the CIA to South America not long after the assassination. I imagine that the CIA didn't want to risk that the man who could boast of having fired the headshot that took the life of the US President was walking around freely within US borders. And the fact that he disappeared without a trace further confirms my belief that Charles Rogers was the killer.

With Rogers out of the way, the CIA, the FBI, the mafia and the political establishment, including the new president, ensured that the assassin could never come forward to confess to the murder and reveal who was really behind it - namely Lyndon Baines Johnson and his co-conspirators.



Chauncey Holt was interviewed several times about his whereabouts at the time of President Kennedy's assassination and has reiterated that he was at the railway crossing, and that from there he moved quickly in the direction of the parked railway carriages, together with the two others who were later arrested in one of the carriages. However, he has not confessed to being involved in the plot itself but was at the scene as a kind of observer, with orders to get quickly into hiding if something unexpected happened. And when they heard shots and screams, they hurried to hide in a railway carriage, according to Holt. Still image from youtube.
